**\* Mess Fee Adjustment:**

The adjustment pertains to the Odd Semester of the Academic Session 2025–26, as the University commenced academic activities on 25.08.2025, whereas the mess fee was charged w.e.f. 10.08.2025 for 2nd, 3rd, 4th, and 5<sup>th</sup> year students only.

Accordingly, the adjustment is applicable only to those students who actually availed the mess facility and deposited the full mess fee during the Odd Semester.

**Note:**

1. Mess Fee has been calculated w.e.f. 15<sup>th</sup> February to 30<sup>th</sup> June, 2026 and as per the new tender quoted rate @ Rs. 158.00/- (Per Day)
2. No students shall be allowed to reside in the Hostel without submission of Mess Fees.
3. Students are required to pay the fees through ERP. No fee shall be accepted except ERP (SBI Epay).
4. Mess Fee is compulsory for all Hostel residents. Further, Non-Residents to Hostels seeking exemption from Mess facility are required to apply for Mess Fee exemption through Dean Student Welfare.
5. In respect of 1st year students who joined the University at a later stage during admission in the Academic Session 2025–26 and had deposited the full Mess Fee, the excess amount has already been adjusted and duly updated in the ERP system.
