- (iii) Literature Review (A Review of the relevant Literature reflecting previous works in the area of proposed research)
- (iv) Statement of Problem/Problem Profile
- (v) Objectives (This will include tentative objectives framed by scholar to be achieved by conducting the proposed research. These objectives will indicate the major aspects of the study to be undertaken including limitations.)
- (vi) Research Question/Hypothesis (in case of non-doctrinal study, hypothesis is mandatory)
- (vii) Significance of Study (justification for undertaking the proposed research is required, and the same should be framed as per the existing literature. The justification framed should indicate general as well as specific benefits likely to be achieved as a result of completion of the proposed research.)
- (viii) Research Methodology
- (ix) Plan of Study/Chapterisation
- (x) Bibliography
- Application forms (duly filled in all respects) should be converted into PDF and should be sent at <a href="mailto:admission@hpnlu.ac.in">admission@hpnlu.ac.in</a> with the following subject "Application for Ph.D. Programme 2020-21". Application forms submitted through any other mode shall not be accepted.
- 8. Self-attested Copy of relevant Degree/ Certificates / Marksheets scanned and converted into PDF and merged into single PDF document is required to be attached with the Application Form.

# 9. Screening Criteria

Candidates (five times of the notified vacant seats) will be invited for presentation of the Research Proposal. For this purpose, the applications will be screened on the following criteria:-

(i) UGC/NTA-Junior Research Fellowship in Law	- 25
(ii) National Eligibility Test (UGC/NTA-NET)	- 20
(iii) LL.M. Percentage	- 25
(iv) Research Proposal	- 50

[Note: Weightage to LL.M. percentage will be calculated in following manner: LL.M. percentage 50-59= 05 Marks (for SC/ ST/ Specially Abled Person/PWD); 55-59= 05 Marks (for General); 60-69= 10 Marks; 70-79= 15 Marks; 80-89= 20 Marks; 90 and above = 25 Marks]

### 10. General Conditions:

- (i) The candidates are advised to read each and every instruction.
- (ii) The Candidates are advised to fill their correct and active e-mail addresses in the online application as all correspondence will be made by the University through online only. No separate communication will be made.
- (iii) The prescribed qualifications and eligibility are the minimum requirement and the mere fact that a candidate possesses the same will not entitle him/her for being invited for the presentation of the proposal.
- (iv) The Candidates must fill/enter their percentage / CGPA as issued by their institute/college/university. The Candidate must not convert their CGPA into percentage.
- (v) Application submitted by the candidates shall be considered final and binding. Requests for making correction in the application form shall not be entertained.
- (vi) The Candidates should submit applications completed in all respects. No correspondence / communication will be entertained for incomplete application.
- (vii) At the time of admission, each application will be verified via supporting original documents. In case any document/information is found not genuine at the time or after the admission then applicant's admission shall be cancelled, and disciplinary / criminal proceedings will be initiated. Their admission will be purely provisional subject to confirmation that they satisfy the prescribed eligibility conditions
