In case where candidate is unable to submit certificates relating to qualifying examinations, provisional admission will be allowed to all such candidates on the basis of undertaking submitted in this regard. All such admission shall be provisional till December 31, 2021. In case of unavailability of such certificates, student shall submit an undertaking. However, failure to submit such certificate on or before December 31, 2021, will result into automatic cancellation of admission, and the HPNLU fee refund policy will apply accordingly.
