**ON SPOT COUNSELLING (ONLINE) FOR THE ADMISSION**  
**AGAINST VACANT SEATS (UG/PG PROGRAMME)**

This is to notify to all candidates registered for the Vacant Seat Round for the academic session 2025-26 that certain seats, as mentioned below, remain unfilled. In order to complete the admission process by 15<sup>th</sup> September, 2025, the prescribed last date for closure of admission, the Himachal Pradesh National Law University (HPNLU), Shimla, hereby announces the commencement of the **“Online On-Spot Admission Round”** against the following vacancies

(a) **B.B.A. LL.B. (Five Year Integrated Programme).**

2. For the admission to the above-mentioned programme as mentioned above, the registered candidates are required to pay the fee as per details mentioned below :-

(a) **For B.B.A. LL.B.** - ₹ 2,17,500/-. (*Rupees two lakh seventeen thousand & five hundred only*).

3. **Eligibility :** Only the Candidates who have already registered with the University for the Vacant Seat Round (UG/PG Programmes) are “eligible” to apply for this On-Spot Admission.

4. **Online Payment Window :** Registered candidates may submit the requisite “admission fee” through the University’s payment portal from **10<sup>th</sup> September to 12<sup>th</sup> September 2025**. No payment will be accepted after the said timeline.

5. **Admission Process:** Admissions will be made strictly based on “**seat availability in respective programmes**” and “**inter-se merit**” among those who have paid the fee.

6. **Fee Refund :** In the event a candidate remits the fee but does not secure admission due to unavailability of seat, the entire fee paid by the candidate will be refunded. No candidates will be penalized for non-admission in such cases.

7. **General Clarifications:**

(a) The online counselling will be conducted strictly only for the Candidates registered with the University for the vacant seat round on the basis of their **CLAT-2025 inter-se merit**.

(b) Registered Candidates who wish to take admission are required to pay the fee online as mentioned above at para 2 above. The last date to pay the fee is **September 12, 2025 at 05:00 PM**.

(c) Candidates who have already paid the fee and not yet allotted a seat so they are not required to pay the fee again. Their admission shall be considered on the basis of **“inter-se merit”** and seat availability in the respective category of candidate.

(d) The number of seats may vary depending upon vacancies on the date of counselling.

(e) Mere submission of the fee does not guarantee admission.
