About Institute of Correctional Administration



Institute of Correctional Administration, Chandigarh is a Society registered under the Societies Registration Act and was established under the overall administrative control of the Govt. of India, Ministry of Home Affairs, New Delhi. It is an autonomous body and running its affairs out of the grant-in-aid received from the Ministry of Home Affairs. All its affairs are being regulated by the Board of Management and thereafter its approval from the Government of India. All India Jail Reforms Committee (1980-83) had laid emphasis on training of prison personnel and the Cabinet Committee on Political Affairs while considering the scheme on Modernization of Prison Administration decided in their meeting on 2.8.1988 that the Regional Training Centres for Prison Personnel should be established by the Central Government preferably in Union Territories. In pursuance to this decision it was decided to set up an Institute of Correctional Administration at Chandigarh and to develop it as a Regional Institute on lines with the existing Institute at Vellore which caters to the training needs of Correctional Officers in the States Southern of Tamil Nadu. Kerala. Karnataka and Andhra Pradesh. Institute of Correctional Administration, Chandigarh aims to impart training in Correctional Administration and allied subjects; promote and provide for the study of Correctional Administration; undertake, organize and facilitate training courses, conferences and lectures and research in matters relating to Correctional Administration and Publication of research papers and books in the area of correctional administration.

The Institute has well furnished rooms for accommodation of trainees and resource persons and is well equipped with professional facilities. The Institute imparts training to prison personnel from all over India as well as to police personnel of Himachal Pradesh and U.T., Chandigarh. The Institute has conducted more than 600 training programmes, trained more than 6000 prison personnel of different ranks, a similar number of medical officers have been trained, 59 paramilitary doctors, and 1853 officers of various other law enforcement agencies like police and judiciary since 2000. The Hon'ble High Court Judges, Professors in the Universities from various disciplines viz., Psychology, Sociology, Criminology, Laws, Psychiatry and Jail Administrators have been participating as guest faculty in the training Programmes of the Institute. Recently it has started training programmes on Human Rights and Women's Rights for paramilitary forces.

About the Training Programme



In collaboration with the Institute of Correctional Administration, Himachal PradeshNational Law University, Shimla is organising a 3-day outreach training programme on '**Mandela Day: Prisoner Reintegration'** from the 4th July to the 6th July, 2022 at Shimla for Prison Officers. Social reintegration can be understood as the support given to prisoners during reentry into society following imprisonment. A broader definition, however, encompasses the period starting from prosecution to release and post-release support.

In the prison setting it refers to assisting with the moral, vocational and educational development of the imprisoned individual via working practices, educational, cultural, and recreational activities available in prison. It includes addressing the special needs of prison inmates, with programmes covering a range of problems, such as substance addiction, mental or psychological conditions, anger and aggression, among others, which may have led to offending behaviour. Reintegration encompasses the prison environment, the degree to which staff engage with and seek the cooperation of individual prisoners, the measures taken to encourage and promote contact with family, friends and the community. It also refers to opportunities provided for prisoners' gradual re-entry into society, such as furloughs.

The main aim of this out-reach training programme is to sensitize the prison officers about their role in prisoner reintegration and various initiatives be undertaken by them for prisoners' reintegration.
