ABOUT THE COMPETITION

After witnessing a great response and appreciation from the participants across 32 premier law colleges and assessors across the globe in our past two flagship national mediations, the **Samanvay International Mediation Competition, 2023** is yet another step taken by the Centre for ADR and Professional Skills, HPNLU, Shimla towards acting as facilitator in increasing the love for Mediation among aspiring students. In the milieu of the backlog of cases reaching its saturation, Alternative Dispute Resolution such as Mediation and Negotiation provide a practical way out.

The competition seeks to provide a prodigious experience that will amplify the interests of young minds in this niche practice of law. The competition will help students brainstorm probable solutions for realistic challenges while providing them with the comfort of choosing their roles as per their preferences. It, therefore, tries to break the monotony of theory-based learning and helps students in putting their knowledge and skills to use.

This competition will also provide an opportunity for the participants to develop the requisite negotiating and communication skills through training sessions conducted by industry professionals. The appealing and ever-growing fields of the law will be selected for this competition to expose the participants to a situation where the interests of clients are multifold, often going beyond mere commercial interests. The participants are expected to take a multi-dimensional approach to reach a settlement, showcasing the variety of skills that can be useful in effective mediation.

GENERAL INFORMATION

ELIGIBILTY

- 1. The competition is open to every student pursuing a five-year or threeyear course in law from any recognized Schools/Colleges/Universities.
- 2. For eligibility, it is hereby clarified that all the participants in one team shall belong to one institution only. No cross-institutional composition of teams is allowed.
- 3. The provisional registration is to be done by the respective institutions officially. Each institution can reserve a maximum of two slots in the provisional registration.

TEAM COMPOSITION

- 1. Each team shall comprise 3 participants- one mediator, one client, and one counsel.
- 2. The roles of the participants must remain the same throughout the rounds.

FORMAT

- 1. The Mediation Propositions for the Preliminary Rounds is being released herewith.
- 2.In order to qualify for the oral rounds, the teams have to prepare and submit 2 Mediation Plans based on the propositions for Preliminary Round I and II. The top 32 teams selected upon assessment of their written submissions shall proceed to the oral Rounds based on the cumulative scores for their written submissions.
- 3. There will be a total of 6 rounds- 2 Preliminary Rounds, one Octa-Final, one Quarter-Finals, one Semi-Finals, and the Final Round.
- 4. Post preliminary rounds, ballots will be scored for each team, and the top16 Negotiating pairs and Mediators will qualify for the Octa-Finals.

5. Post Octas, ballots will be scored for each team, and the top 8 Negotiating pairs and Mediators will qualify for the Quarter-Finals.

6. The Teams that qualify for the Quarter Final rounds shall be invited to the HPNLU Campus for competing in the Advanced Rounds.

7. Post Quarters, the top 4 Negotiating pairs and Mediators shall qualify for the Semi-final Rounds on a knockout basis.

8. Post the Semi-Finals, the top two performers from each category of roles, i.e., Negotiating pair and Mediator, played by the participants, will qualify for the Final round, on a knockout basis.

MODE

- 1. The Competition shall be held in **Hybrid** mode, whereby the Training, Workshop, Inaugural Ceremony, Preliminary Rounds and Octa Final Round shall be conducted virtually via Google Meet, while the Quarter Finals, Semi Final and Final rounds of the competition shall take place physically at the university campus.
- 2. Kindly note that the Offline conduction of the advanced rounds shall be contingent on the weather conditions of Himachal Pradesh and may be shifted to the Online mode in case the same is not favorable.

REGISTRATION

- 1. Provisional registration shall be opened for all eligible institutes from which thirty-two (32) teams will be selected for the competition.
- Selection will be based on the screening process comprising of assessment of the two Mediation Plans with respect to the Propositions of Preliminary Rounds I and II.

3. Provisional Registration Amount -

- Indian Teams INR 2,000/-
- Foreign Teams \$ 30/-

4. The institutes must complete the "Provisional Registration" only through the Google Form link annexed below, on or before **5th October 2023**.

After the assessment of the Mediation plans, the final list of teams (along with the waiting team list) will be released by *6th October 2023*.
The "Final Registration" shall be completed only when the participants pay the registration fees, which shall be done on or before *10th October 2023*.
Final registration details will be released to participants individually via e-

mail only after completing the provisional registration process.

9. Final Registration Amount (the details for final registration shall be shared after selection of the final teams) -

- Indian Teams ₹ 8,000 (rupees eight thousand only)
- Foreign Teams \$ 130 (one hundred and thirty dollars only)




