ABOUT THE COMPETITION

Himachal Pradesh National Law University, Shimla, (HPNLU, Shimla) is delighted to announce **5th HPNLU National Moot Court Competition, 2024**. This flagship event has been devised with the aim to create an opportunity for learning the development of jurisprudence on emerging trends in constitutional law, besides armouring the upcoming generations of the legal fraternity with research and oratory skills. The Moot Proposition of the Competition will revolve around **Constitutional Law**. However, the participants will be expected to explore different dimensions of law and not restrict themselves to the theme of the Competition.

In the past, HPNLU, Shimla has successfully conducted four editions of its National Moot Court Competition, all of which witnessed significant participation of law students from all over India. Keeping up with the spirit of mootng, this year as well, we are delighted to organise our flagship event in **hybrid mode**. We cordially invite students pursuing 3-year LL.B. programme or a 5-year integrated LL.B. programme from institutions across India to participate in the competition. A detailed invite will be released soon including the Brochure, Rulebook, Moot Problem and timeline of the event.

ABOUT HPNLU, SHIMLA

The Moot Court Committee (MCC) is the official student committee for managing moot activities and events at HPNLU. In order to foster the culture of Moot Court Competitions, the University is organising its 5th National Moot Court Competition 2024.

FORMAT OF THE COMPETITION

The Competition will be conducted in **hybrid mode**, and the venue for the same would be our picturesque campus of Himachal Pradesh National Law University, Shimla. This edition's proposition will revolve around contemporary and developing themes of Constitutional Law and other integrated themes of law.

The Competition will be conducted in two phases, which are as follows:

ONLINE ROUNDS (6TH-7TH NOVEMBER, 2024)

- Preliminary Oral Rounds.
- Quarter-Final Rounds & Researcher's Test.

&

OFFLINE ROUNDS (16TH NOVEMBER, 2024)

- Semi-Final Rounds & Final Round.

To confirm participation teams must fill out the provisional registration form by **30th September, 2024** followed by final registration for the top **32 teams** based on a first-come- first basis along with the payment of INR **4000** (Rupees Four Thousand Only) before the deadline i.e. **8th October, 2024**.

The teams qualifying for offline rounds shall be required to make an additional payment of INR **4000** (Rupees Four Thousand Only) on or before **11th November, 2024**.

The Moot Court Committee at HPNLU Shimla welcomes Institutions from all over the country. All interested institutions may show their interest by provisionally registering for the Competition by filling out the Google form given below:

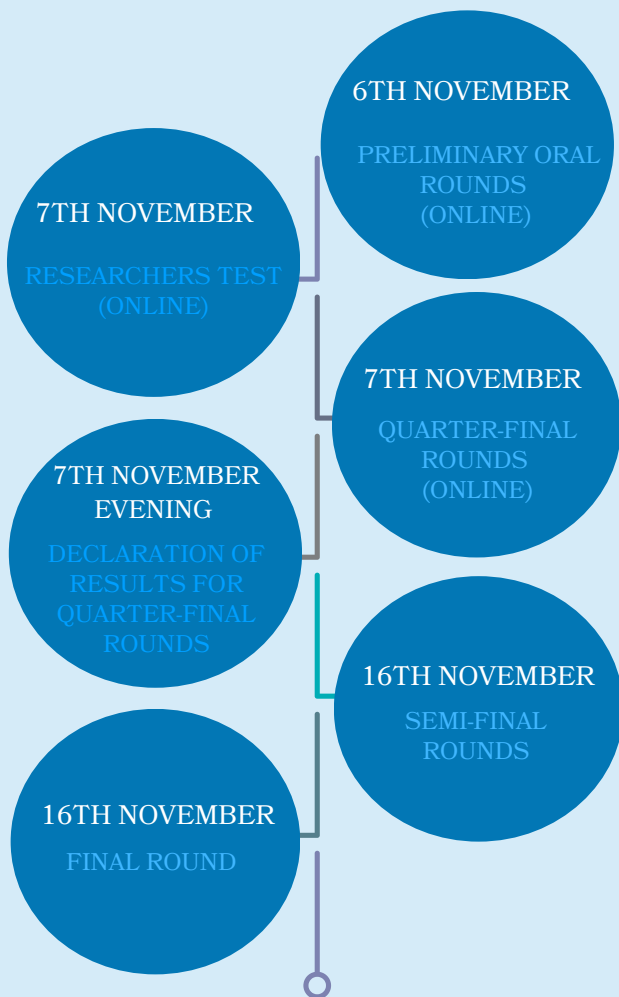

Please note that no more than one team shall be allowed to represent any Institution. The first **32 teams** to finally register will be participating in the online Preliminary Rounds. A total of **8 teams** will qualify for the online Quarter-Final Rounds, **4 teams** will proceed to the offline Semi-Finals and **top 2 teams** will proceed to the Final Round. The Main Brochure, Moot Proposition and the Rule Book shall be released latest by **1st October, 2024**.

TENTATIVE TIMELINE OF THE COMPETITION





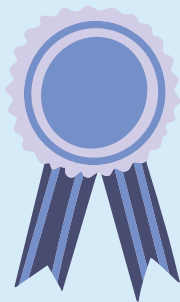
