|--------|------------------------------|---|
| 1.     | 100% *                       | Till 15 <sup>th</sup> August 2022 (15 days or more before the formally-notified last date of admission).                              |
| 2.     | 90%                          | From 16 <sup>th</sup> August to 31 <sup>st</sup> August 2022 (Less than 15 days before the formally-notified last date of admission). |
| 3.     | 80%                          | Till 15 <sup>th</sup> September 2022 (15 days or less after formally-notified last date of admission).                                |
| 4.     | 50%                          | <b>Till 30<sup>th</sup> September 2022</b> (30 days or less, but more than 15 days, after formally-notified last date of admission).  |
| 5.     | 00% **                       | From 1 <sup>st</sup> October 2022 onwards (More than 30 days after formally-notified last date of admission).                         |
