## NOTICE

**(B.A./B.B.A. LL.B. FYIC Academic Session: 2019-2020) 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup> and 8<sup>th</sup> Semesters Reappear/ Improvement Examinations, January 2021.**

As per the guidelines of the UGC and Circulars, Press Release of the Bar Council of India, and decision of the HPNLU COVID-19 Cell, the (Special) Reappear/Improvement Examinations for 2<sup>nd</sup>, 4<sup>th</sup>, 6<sup>th</sup> and 8<sup>th</sup> academic session 2019-2020 and 3<sup>rd</sup>, 5<sup>th</sup> and 7<sup>th</sup> Semesters Academic Session 2019-2020 shall be held in January, 2021.

The date sheet shall be notified after the compilation of data of Reappear Examination Form to be filled by concerned students.

Kindly note that entitlement/eligibility for improvement in any paper(s) applies only for semesters 2<sup>nd</sup>, 4<sup>th</sup>, 6<sup>th</sup> and 8<sup>th</sup> which fell under COVID-19 Pandemic duration.

All interested students are required to compulsorily fill up the Examination Form uploaded on the website of the University latest by 12<sup>th</sup> of January, 2021. The link of the Examination Form is given below (<https://forms.gle/5J59juBDZxJXymEYA>). The Reappear/Improvement Examination fee is Rs. 1000 per subject. The same is to be deposited to the Accounts Branch of the University and the details of the payment is to be mentioned in the Examination Form.

The Examination Forms of students whose name is not cleared (by the Accounts Branch) in respect of the Semester fee (both previous Semester i.e. 2019-2020 and current Semester i.e. 2020-2021), shall not be accepted.

The cross-list containing details of the marks obtained in the above semester by students is uploaded on the University website.

The Brief details of the examinations are given below. Complete instructions and guidelines for students (including Date Sheet) shall be notified subsequently.

1. **Mode of Examinations:** Students are required to write Online Examinations Open Book Examinations (OBE), by hand, on Physical Answer Sheets (A4 Size Paper) and submit the scanned copies thereof within the prescribed time period.
2. **Question Paper and Weightage of Marks:** The Reappear/Improvement Examinations shall be conducted for 50 Marks (each course/paper). The Question Paper shall consist of two sections *i.e.* Section A and Section B. Section A shall consist of 3 short answer type questions and Section B shall contain 3 long answer type questions, covering the entire syllabus. The students are required to answer any two questions, each, from Sections A and B.

The Reappear/Improvement Examinations are only meant for End Term Examinations. The marks secured by students in the respective subject in the Mid Term/Internal Assessment/Project Assignment Presentation shall continue to be the same.

3. **Maximum Time Allowed:** Maximum time allowed for writing Examination shall be 2 hours and for scanning and uploading of Answer Sheet, 1 hour shall be given.
4. **The detailed instructions and guidelines for students, concerning the Reappear/Improvement Examinations shall be notified subsequently.**
