It is further informed that the payment of fees for the above-mentioned courses, B.A./BB.A. LL.B. for the Academic Session 2022-23, shall be accepted through State Bank Collect (https://www.onlinesbi.com/sbicollect/icollecthome.htm) Note:

- 1. The students who intend to deposit the fees through Demand Draft on account of their education loan are advised to request their banker to deposit the fee through SBI Collect to Himachal Pradesh National Law University (H.P.) or through Demand Draft in favour of Registrar, Himachal Pradesh National Law University, Shimla.
- 2. Students who have already paid fees for the Academic Session 2022-23 are required to complete the Admission process by filling out Admission Forms etc.
- 3. As per the rules it is mandatory for all the students to complete the requirements of Admission by paying fees i.e. Admission in 2<sup>nd</sup> Year, 3<sup>rd</sup> Year, 4<sup>th</sup> Year, and 5<sup>th</sup> Year. Only those students who fulfill the mandatory requirements shall be allowed to fill up the Mid-Term Examination form and be allowed to attend classes.
- 4. Any Students who fails to complete the requirements of Admission for the Academic Session 2022-23, shall not be allowed to sit in the Mid-Term Examination.
