EVALUATION PROCESS

The evaluation and marking process at HPNLU, Shimla is comprised of a rigorous system of examinations, assignments, presentations, attendance and moot courts. At the end of each semester, every student is evaluated for 100 marks for each subject. Credit connotes the unit that gives weight to the value level or time requirement of a course. 1 Credit shall be equal to 15 Teaching Hours. If a course has 6 papers in Semester, and each paper is has 4 Credits, then the total credits of the paper of the Semester shall be calculated 4 (credits per paper) * 6 (number of papers) = 24 (Total Credits of the Subject). Grade value shall mean the value assigned to the marks obtained by a student on a paper. Grade value is based on a 10-point scale. Letter Grade shall mean the Alphabetical Grade/s determined on the basis of Grade Value obtained by the Student in a paper. The Grade Value on the 10-point scale, and the letter grade to be given to the student, is on the basis of the Grade Value obtained by the Student. The table is given below shows the marks range, grade value and corresponding letter grade.

Grade Point shall be calculated by multiplying the Grade Value obtained by the student and the Credits of the paper. For example, if the student secures the Grade Value 08, and the Credit of the Paper is 04, then the Grade Point of the student in that paper shall be 8*4= 32. Semester Grade Point Average (SGPA) of a student shall be calculated as the sum total of the Grade Points secured by the student in all the papers of a semester divided by total Credits (sum total of credits of all the papers in that semester) in a semester.

Cumulative Grade Point Average (CGPA) shall be the sum total of Quality points of all the Semesters of a course till date divided by Total Credits of the Course till date. CGPA shall be considered up to two decimal places. CGPA = Total Quality Points in a Course + Total Credits of the Course

RESEARCH AT HPNLU

CENTRE FOR ENVIRONMENT AND DISASTER MANAGEMENT

CEDM is a specialized Centre for conducting socio-legal research in the field of environment protection & disaster management. It aims to serve as a research and training centre in the field of environmental law and policy. It has a quarterly newsletter 'HPNLU GREEN GAZETTE' in circulation and a Journal 'HPNLU Journal for Environment and Disaster Management is up for publication.

CENTRE FOR LAW, BUSINESS AND ECONOMICS

Centre for Law, Business and Economics aims at institutionalizing and channelizing research on corporate and business-related aspects that take place nationally and globally. The Centre undertakes activities including discussions and expert talks that inculcate and facilitate the students to have a thorough understanding of the corporate structure, its market, its regulatory framework etc.

CENTRE FOR COMPARATIVE PUBLIC LAW

The Centre for Comparative Public Law is established to undertake studies and investigation in core areas of public law and advanced jurisprudence as well as comparative private law, and comparative legal systems. It had undertaken a project on Socio-economic Rights of Building and Construction workers: A study of implementation of laws and rules in the state of Himachal Pradesh. The Centre has successfully organized a two week long Capacity Building Programme on Comparative Public Law and Hindu Philosophy: Research and Teaching Dimensions in 21st Century India.

CENTRE FOR PARLIAMENTARY STUDIES

The Centre for Parliamentary Studies is established to undertake studies related to the functioning of parliament. It aims to bring stakeholders for discussion on contemporaneous issues and challenges before the parliament.

CENTRE FOR CHILD AND WOMEN STUDIES

CCWS aims to serve as a research and training centre in the field of development of women and children. It is created to assist the governments in making better laws and policies pertaining to women and children rights. It had conducted a webinar on the theme of Reproductive Rights of women in Changing World: An Expression of Autonomy of Choice.

CENTRE FOR HUMAN RIGHTS

The focus of the Centre is research on human rights related to the subaltern social groups, especially Dalits, women, indigenous communities and religious, ethnic and linguistic minorities. The Centre has organised a colloquium on Human Rights in Covid-19.

CENTRE FOR ALTERNATIVE DISPUTE RESOLUTIONS AND PROFESSIONAL SKILLS

The Centre for Alternative Dispute Resolutions (ADR) and Professional Skills primarily aims to promote the research in the field of dispute resolution mechanism in India, and provide a platform to engage students, practitioners and other experts; and collaborate with various bodies, including government and non-governmental at national and international level, research institutions, academic institutions to conduct research and spread awareness about the ADR. It has a quarterly e-Newsletter in circulation, primarily aimed at catalysing awareness on ADR and fostering ADR culture through student's engagement in research avenues.

CENTRE FOR CRIMINOLOGY AND FORENSIC SCIENCE

This Centre creates a platform for discussion on the development of criminal laws in India. It has submitted the proposal for reforms in criminal law to the Ministry of Law and Justice, Government of India.

CENTRE FOR HUMAN RESOURCE DEVELOPMENT

The Centre recognizes the instrumental role played by human resources, in particular, education and health in fostering economic growth and social development and also in promoting global competitiveness.

MOOT COURT COMMITTEE

Moot courts are the intrinsic part of a law student's life. The Moot Court Committee at HPNLU strives to provide students with practical exposure to the various legal issues and encourages them to participate, research and develop new skills in the field of law. To promote the mooting culture on campus, it regularly organizes workshops on mooting skills, Intra moot court competitions. Even in this global pandemic MCC has successfully conducted its flagship National Moot Court Competition.





'PARICHARCHA' DEBATING SOCIETY

Debating is an essential skill for a law student and *Paricharcha*, HPNLU's Debating Society has always been working towards inculcating this art in all the students. To inculcate the skill of debating, it conducts weekly debate sessions on contemporary themes and encourages students to participate in National and International Debate Competitions.

LEGAL AID CLINIC

Legal services should be accessible to all with guiding principle LAC, HPNLU has adopted villages in the vicinity of campus. In these villages, it runs legal awareness drives. It has also registered in the Pro Bono Club scheme of the Department of Justice, Ministry of Law and Justice, Government of India, to improve efficiency & quality of pro bono legal services by providing assistance in legal research. It has engaged in Philanthropic activities like Blood Donation camp, distribution of Sanitary napkins. It has Gadzookery, the Nukkad Natak group, which performs on burning social issues to create awareness among the masses.



CAMPUS MENTORING CELL

RECRUITMENT PROCEDURE & GUIDELINES

The Recruitment Process is conducted by the Internship and Placement Committee of the University. It is an integral process that aims at facilitating the reach between graduating students and prospective recruiters. The recruitment process is governed by the Recruitment Process Rules, for the facilitation of the recruitment process.

- Pre-Placement Talks: Recruiters are encouraged to conduct an interactive session, either on-campus or through video conferencing, highlighting the salient features of the organisation, the job profile being offered, remuneration, terms and conditions of employment and other relevant information as the recruiter thinks fit at any time before the screening process.
- Pre-Interview Screening: Recruiters can conduct a Pre Interview Screening Process including group discussions any time before the interview day. Recruiters are free to determine their own policy for the Screening Process to shortlist students. In case the Recruiter has no particular method of Pre Interview Screening, the Curriculum Vitae of all interested students shall be forwarded to the Recruiter.
- Final Interview: On the basis of the screening process, those students who are selected, shall be interviewed. As per the wish of the recruiter a waitlist of students, if needed, may be prepared to use in case of failure of appearance in the interview by screened candidates.
- Final intimation of Offer: The recruiter has to send the offer letter to the students through the Placement Cell only.

Recruiters can visit the Campus for the recruitment procedure or they can opt for any suitable mode they think fit.
