2. **Full Time Ph.D. Programme** : Candidates mentioned in the list shall be confirmed as admitted provisionally for full time Ph.D. Programme, after verification of admission fee by the account branch and submission of requisite/qualifying documents. Admission fee for the full time Ph.D. Programme is **₹ 91,000/- (Rupees ninety-one thousand only)**.

3. **Part Time Ph.D. Programme** : Candidates who wish to take admission in Part-time Ph.D. Programme are required to fulfill the following conditions as per UGC Regulations, 2022 :

- (a) Applicant/candidate must be in full time regular employment.
- (b) **“No Objection Certificate”** from the appropriate authority in the organization where the candidate is employed, clearly stating that:
 - (i) The candidate is permitted to pursue studies on a part-time basis.
 - (ii) His/her official duties permit/him/her to devote sufficient time for research.
 - (iii) If required, he/she will be relieved from the duty to complete the course work.
- (c) The student must have successfully completed the course work prescribed within the duration from the date of his/her registration.
- (d) The maximum duration will be same as per the UGC Regulations, adopted by the University time to time.

4. **The admission for the Part Time Ph.D. Programme shall be subject to submission and verification of the documents as quoted at Para 3 above.** Admission fee for the Part Time Ph.D. Programme is **₹ 1,04,000/- (Rupees one lakh & four thousand only)**.

5. The last date to pay the fee is March 3rd, 2025. If shortlisted applicants fail to pay the fee in stipulated time, their respective seats shall be offered to the wait list applicants.
