





The University is recognized by the UGC under Section -2(f) of the UGC Act, 1956 and The Bar Council of India.



The Himachal Pradesh National Law University, Shimla, placed in the geographical terrains of the Himalayas is in the Ninth Year of its existence under the dynamic leadership of the Vice-Chancellor, (Officiating) Prof. (Dr.) Chanchal Kumar Singh. The institution is one of the few educational centres in the country which enjoy the natural environment and magical beauty of locational topography, excellent and enjoyable weather conditions throughout the year. The University in these respects is bestowed with all-natural conditions facilitative of creation, pursuit and dissemination of knowledge.

HPNLU, Shimla was established by the Himachal Pradesh National Law University Act, 2016 (Act 16 of 2016) in September 2016. The University shifted from the Himachal Pradesh Judicial Academy premises to its own campus during the Academic Session 2019-20. The new campus has been developed by the Public Works Department (PWD), Government of Himachal Pradesh. The first phase of construction that included the Academic and the Administrative blocks as well as the Girl's hostel is complete. Foundation stone of the Rishika sanghmitra Girl's Hostel of Himachal Pradesh National Law University, Shimla was laid by Shri Sukhvinder Singh Sukhu, Hon'ble Chief minister, Himachal Pradesh and Hon'ble Mr. Justice Amjad Ahtesham Sayed, Chief Jusice, High Court, Himachal Pradesh and Chancellor, HPNLU, Shimla in the august presence of Prof. (Dr.) Nishtha Jaswal, Former, Vice Chancellor, Himachal Pradesh National Law University, Shimla The process for construction of boys' hostel and residential complexes for teaching and non-teaching staff is yet to be initiated.

The University started functioning from 5th of October, 2016. It is a participating University of the Consortium of National Law Universities (NLUs). The batches of B.A. LL.B. and B.B.A LL.B. (Five-year integrated course), LL.M. (One Year Programme) are admitted through CLAT (Common Law









Admission Test). The University conducts every year, its own national level test for selecting candidates for the Ph.D. Programme in Law. Currently the ninth batch of Undergraduate students and the eight batch of Post Graduate students and Ph.D. students are pursuing their respective courses.

The students are provided hostel accommodation facilities within campus premises/ rented and private buildings. Conveyance facilities between hostels and campus are provided through the University bus. There is a central mess facility in each of the hostels. Hostel rooms are duly furnished with beds, study tables, chairs and almirahs. Hygiene and proper sanitation are maintained and Wi-Fi facilities are available. For safety and security of residents, each hostel has security guards.

Himachal Pradesh National Law University (HPNLU), Shimla, now boasts a gymnasium facility separately for boys and girls dedicated to ensure access to top-notch exercise equipment and fitness programs for overall health and wellness of the students.

The University has an ambulance facility and medical care is provided through the Government Hospital located at Dhami which falls within three kilometers from the University campus.



ADMISSION RULES

Relevant rules applicable to admission to different courses of the University as contained in Himachal Pradesh National Law University, Shimla (Courses of Study, admission & Curriculum) Regulation, 2019; Part-I of Himachal Pradesh National Law University, Shimla, Academic Regulation, 2019 are reproduced below:

1. ELIGIBILITY CRITERIA FOR DIFFERENT COURSES/PROGRAMMES

- 1.1 Under Graduate Programme: For all Undergraduate Programmes like B.A./B.B.A. LL.B. (Hons.) (Five-Years Integrated Course), admission shall be done on the basis of Common Law Admission Test (hereinafter referred to as CLAT). Candidates should have passed 12th (10+2) examinations from any recognized board with a minimum of 50% marks or an equivalent grade. The cut off marks/grades for candidates belonging to Scheduled Castes and Scheduled Tribes (SC/ST) shall be 45%.
- **1.2 Post Graduate Programme:** Candidates should have passed LL.B. Degree (3 years or 5 years) from any recognized University/Institution in India or Foreign University/Institution recognized as equivalent under Indian Law with a minimum of 50% of marks or equivalent grade.

Provided, in case the candidate belongs to SC/ST Category, the cut off marks/grades shall be 45%

Explanation 1: In determining equivalency, the University listed with Association of Indian Universities and any other nodal agency which is statutorily empowered to determine equivalency, will be considered.

Explanation 2: Candidates appearing in the qualifying examination shall also eligible to apply.

Explanation 3: There shall be no upper age limit.

Tie Breaker Rule: In case of equal marks, the break of tie shall be as per the following procedure and order:

- .. Higher age;
- ii. Computerized draw of lots;²
- **1.3 Doctor of Philosophy in Law:** Admission shall be made as per the Himachal Pradesh National Law University Shimla Regulations for the Doctor of Philosophy in Law (Ph.D.) and Post-Doctoral Research in Law (LL.D.), Part-III.
- **1.4 Post Graduate Diploma Programmes:** Minimum qualifications shall be as follows:

Graduate Degree in Law or other relevant field from any University/Institution recognized in India or Foreign University/Institution recognized as equivalent under Indian Law with a minimum of 50 % marks.

1.5 Any Other Programme: As approved by the Competent Statutory Body from time to time.

Explanation 1: In determining equivalency, the University listed with Association of Indian Universities and any other nodal agency which is statutorily empowered to determine equivalency, will be considered.

Explanation 2: Candidates appearing in the qualifying examination shall also be eligible to apply.

Explanation 3: There shall be no upper age limit for admission to these courses.

3A. ADMISSION TO DIFFERENT COURSES/ PROGRAMME OF THE UNIVERSITY³

- **3A.1** Admission to different Undergraduate Courses, Post Graduate Programmes and Doctor of Philosophy in Law shall be done by such committee consisting of such number of faculty members as may be constituted by the Registrar with the prior approval of the Vice-Chancellor.
- **3A.2** The Admission Committee shall be headed by the Dean Academic Affairs, a senior faculty member.
- **3A.3** It shall be overall responsibility of the Establishment Branch headed by the Registrar of the University to complete admission process in the first year of Course/ Programme and Doctor of Philosophy in Law, within the time notified every academic year with the approval of the Vice-Chancellor.

3B. ADMISSION TO SUBSEQUENT YEARS OF DIFFERENT COURSES/ PROGRAMME OF THE UNIVERSITY

- **3B.1** There shall be a Standing Admission Committee for smooth conduct of admissions in all subsequent years i.e. 2nd, 3rd, 4th and 5th year of Courses in B.A./B.B.A. LL. B (FYIC) of the University.
- **3B.2** The Standing Admission Committee shall be headed by the Dean Academic Affairs and it shall consist of four faculty members, of which at least one member must be female faculty member, to be nominated by the Registrar with the approval of the Vice-Chancellor. The Registrar may with the approval of Vice-Chancellor, appoint any number of Sub Admission Committee comprising of faculty members for admission in 2nd, 3rd, 4th and 5th year.
- **3B.3** There shall be separate Sub-Committees for admissions in 2nd, 3rd, 4th and 5th years each.
- **3B.4** Each Sub-Admission Committee shall have at least three faculty members.
- **3B.5** The Standing Admission Committee shall have requisite secretarial staff drafted or provided by the office of Registrar for smooth conduct of the admissions.

Inserted as per the decision of 8th Meeting of Academic Council held on 22nd December, 2020 and approved in the 9th Meeting of the Executive Council held on 22nd December, 2020.

- **3B.6** All Sub-Admission Committees shall function under the immediate supervision of the Standing Admission Committee.
- **3B.7** Responsibilities of Standing Committee;
 - i. Development of Admission Form for the different Semesters/Streams/Disciplines
 - ii. Development of check list of the documents to be supplied by students at the time of admission along with the Admission Form
 - iii. To ensure that the information provided by the students is correct and is supported by required documents
 - iv. To ensure that no student is given admission in 2nd, 3rd, 4th or 5th year without compliance by him/her of all the documentary requirements and payment of prescribed fee for the year/semester concerned.
- **3B.8** All admissions in 2nd, 3rd, 4th or 5th year, as the case may be, shall be completed during the period of 15 days immediately preceding the first day of the new Academic Session prescribed in the Academic Calendar of every year of the University.
- **3B.9** Every student shall be required to fulfil the requirement of admission in 2nd, 3rd, 4th or 5th year, as the case may be, by submitting complete admission form along with all requisite documents through the respective Sub Admission Committee to the Standing Admission Committee within the time notified by the Standing Admission Committee.
- **3B.10** A Student who fails to complete the requirements of Rule 3B.9 shall not be eligible for getting his/her name on the rolls/attendance register of the relevant year of the Course/Programme.
- **3B.11** The Standing Admission Committee shall forward/provide the complete lists of rolls/attendance register with respect to 2nd ,3rd, 4th or 5th year, as the case may be, to the Establishment Branch of the University, and the Registrar shall forward the same to the Dean Academic Affairs and the Examination Branch. The Registrar shall forward to the office of examination department and to the office of Dean Academic Affairs the list of students who have been granted exemption under Rule 3C.5, on or before the first day of every academic year.
- 3C. PAYMENT OF PRESCRIBED FEE BY THE STUDENTS WITH RESPECT TO 2nd, 3rd, 4th OR 5th YEAR, AS THE CASE MAY BE (ODD SEMESTERS)
- **3C.1** As per the fee structure prescribed/ revised, from time to time, for an academic year the fee may be payable in two instalments.
- **3C.2** All the students shall be required to deposit prescribed fee, if applicable in instalments, first instalment of the fee (odd semesters), during the time period of 15 days referred to in Rule 3B.8 and the same shall be notified by the Registrar.
- **3C.3** If a student fails to deposit fee within the said period, his/her admission form shall not be

- considered by the Standing Admission Committee. Such students shall not be eligible for getting his/her name on the rolls/attendance register of the 2nd, 3rd, 4th or 5th year, as the case may be.
- **3C.4** A student, whose name is not on the rolls/attendance register of the University shall, not be entitled to attend classes or for being allotted hostel accommodation and other benefits.
- In exceptional cases, a student may be allowed, by the Registrar with the approval of the Vice-Chancellor, to take admission without payment of fee, as referred in Rule 3C.2, but after complying all other requirements of Admission Form along with all requisite documents etc. Provided that it is hereby clarified without prejudice to Rule 3C.5, no student shall be allowed to take admission in 2nd,3rd, 4th or 5th year, as the case may be, after 15 days from the date of commencement of classes in that Academic Session.
 - It is further provided that the Vice-Chancellor, on the basis of written justifications supported by sufficient and due document and a proofs, may grant exemption beyond the above 15 days but not more than one month to a student to comply a requirements of Rule 3C.2.
- **3C.6** If a student fails to take admission within prescribed time period, he/she shall be required to re-register in the previous year and shall not be considered for promotion to next higher year.

3D. PAYMENT OF FEE, 2ND INSTALLMENT (EVEN SEMESTERS)

- **3D.1** The Registrar of the University shall notify the time for payment of the second instalment of the prescribed fee (even semesters), as per the fee structure of the University, in the last week of January, every year.
- **3D.2** The students shall be given at least 15 days time to deposit the 2nd instalment of the fee payable.
- **3D.3** A student who fails to deposit the 2nd instalment of fee, referred under Rules 3D.1/3D.2 shall not be eligible for getting his name on the rolls/ attendance register, even semesters, as the case may be.
- **3D.4** The Establishment Branch of the University and the Registrar shall ensure that the Establishment Branch forwards the certified copy of the lists of student, i.e. rolls/ attendance register of the concern students of all the even semesters, who has complied with the Rule 3D.1 and who have been granted exemption under Rule 3D.5, to the Examination Branch and to the office of Dean Academic Affairs on or before the first day of class notified for even semesters.
- **3D.5** In exceptional cases, a student may be allowed, by the Registrar with the approval of the Vice-Chancellor, to deposit the 2nd instalment of fee with a relaxation of 15 days beyond the time, referred under Rules 3D.1/3D.2.
- **3D.6** A student who is covered under Rules 3B.8, 3C.2 and 3D.5, respectively, for 1st instalment and 2nd instalment, shall be eligible to get his name on the rolls/attendance register of the University only, from the date of payment of such fee respectively.

HPNLU

ADMISSION IN 2ND ,3RD , 4TH OR 5TH YEAR, AS THE CASE MAY BE, PAYMENT OF FEE AND **COUNTING OF ATTENDANCE**

- **3E.1** Attendance percentage thereof in any Course of a student who takes admission/pays prescribed fee beyond the prescribed time and as per the Rules 3B.9, 3C.2 and 3D.5, respectively, for 1st instalment and 2nd instalment, shall be counted on the basis of the entire number of classes taken in that course / paper and not from the date on which he/she complete the requirement of admission or pays fee.
- **3E.2** A student who has been declared 'detained due to shortage of attendance', and has not been promoted to next year of the course/programme, shall be required to take re-admission in the said course/programme by submitting a duly filled admission form to the Admission Committee constituted as per Rule 3B and depositing the prescribed fee as per Rule 3C of the HPNLU Courses of Study, Admission and Curriculum Regulations, 2019. Such student/s shall be evaluated as per the Himachal Pradesh National Law University, Examinations Regulations, 2019.

Provided that where a student is declared 'detained' in the 2nd/4th/6th 8th or 10th Semester of B.A./B.B.A. LL.B. or LL.M. 2nd Semester, such student shall be required to re-register for the said semester in the next Academic Session, and shall be required to pay admission, hostel fee etc. for the said semester only.

Provided further that when a student is declared 'detained' in the First Semester of a given Course/Programme, his/her admission shall be deemed to be cancelled.

Illustration:

ADMISSION RULES

- A student of B.A./B.B.A. LL.B. 3rd Semester (Academic Session 2020-21) is declared 'detained' due to shortage of attendance. He/she is required to take re-admission to 2nd year (3rd semester) in the Academic Session 2021-2022 as per the Regulation and shall be required to deposit annual fee as notified.
- A student of B.A./B.B.A. LL.B. 4th Semester (Academic Session 2020-2021) is declared 'detained' due to shortage of attendance. He/she is required to re-register in the 2nd year (4th semester again) in the Academic Session 2021-22 by depositing fee including hostel fee for the 4th Semester. 4

Relevant rules applicable to admission and discipline in hostel as contained in the University, Shimla Hostel Regulation, 2019 are reproduced below:

1. **Short Title, Extent and Commencement**

- These regulations may be called, the Himachal Pradesh National Law University Hostel 1.1 Regulations, 2019.
- These Regulations shall come into force w.e.f. 25th December, 2019. 1.2
- These regulations shall be applicable to all residents of Hostels of HPNLU Shimla. 1.3
- For effective implementation of these regulations various committees may be created by the Vice-Chancellor from time to time.
- 2. **Hostel Administration**
- **Dean Students Welfare:** There shall be a Dean Students Welfare who shall be appointed by the Vice Chancellor.
- 2.1.1 The Dean Students Welfare shall be responsible for the hostel administration and all issues pertaining to the residents in the hostels.
- 2.1.2 The Dean Students Welfare shall also be responsible for the discipline issues in the University Campus.
- 2.1.3 The office of the Dean Students Welfare shall have staff including superintendent, clerk, steno typist, caretakers and a peon and shall be under general regulation of the University.
- Warden: There shall be a warden appointed by the Vice-Chancellor for each hostel of the University. The Vice Chancellor may give additional charge of warden to any faculty member. However, the Dean Students Welfare, with the approval of the Vice Chancellor, may give charge of more than one hostel to the warden.
- 2.2.1 The Warden shall perform his/her duties in consultation with the Dean Students Welfare.
- 2.2.2 The office of the warden shall have staff, including clerks, attendants, security guards etc., and shall be under general regulation of the University.
- The Dean Students Welfare and Wardens shall be paid such honorarium as decided by the Vice-Chancellor from time to time.

Admission: 3.

- **3.1** Students who have joined a regular course of B.A/B.B.A LL.B., LL.M. and Ph. D. in the University shall be eligible for hostel accommodation for the duration of his/her course. The University shall have discretion to allot the Hostel accommodation to a particular student or a group of students based on the parameters of suitability and need, in the broader interest of the academic environment of the campus. The admission to the hostel shall be made on the filling of the prescribed form along with the following documents:
 - photocopy of the fee receipt,
 - medical disclosures/records specifically mentioning blood group, any serious disease and any specific allergies.
- The University may use its discretion judiciously as per the availability of rooms based on proportionality of students.

Inserted as per the decision of the 17th Meeting of Academic Council held on 24th February, 2023 and approved in the 18th Meeting of Executive Council held on 24th February, 2023.

- 3.2.1 Allotment of the rooms generally shall be made on sharing basis for B.A/B.B.A. LL. B. students.
- 3.2.2 LL.M. and Ph. D. students may be provided single room accommodation subject to the availability of rooms.
- 3.2.3 Fresh room allocation will be made in the beginning of each academic year and each resident of the hostel shall vacate the hostel at the end of each Academic Session.
- **3.3** The students shall be allotted rooms by the Dean Students Welfare in consultation with the wardens.
 - 3.3.1 The Students shall occupy the respective rooms allotted to them. The Rooms once allotted to the students for an academic year shall not be changed except under exceptional situations. Under no circumstances the inmates shall exchange rooms without the permission of the warden.
 - 3.3.2 In exigencies, the Warden, with the approval of the Registrar through Dean Students Welfare may shift inmates from one room to another.
 - 3.3.4 Those students, who have been suspended, expelled or rusticated for any reason by the University, shall have to vacate the hostel and may not be considered for hostel admission for subsequent session(s).
- 3.4 It shall be the responsibility of the warden to remove unauthorized occupant from the Hostel on the approval of the Dean Students Welfare.
 - 3.4.1 Those students, who have been declared year-back as per the HPNLU Examinations Regulations shall have to vacate the hostel for the said academic Session.
 - 3.4.2. A student who, without any justification and without permission of the warden, remains absent from the hostel for more than 15 days, shall be deemed to have vacated the hostel.

4. Residence:

- **4.1** The Hostel/s shall remain closed during the vacations as specified in the Academic Calendar of the University. The Residents shall not be allowed to stay in the hostel during that period.
- 4.2 The Residents shall not remain absent from the hostels except in case of academic leave or other leave with prior permission of the competent authority. Any resident who is going to represent the University in any external event shall submit a copy of Academic Leave granted for the same to the office of the warden.
- **4.3** The entry time for the residents is between 6:00 A.M. to 9:30 P.M.
 - 4.3.1 Parents/Local Guardians can meet their wards during visiting hours prescribed by the University in the visitor Room.
 - 4.3.2 The visitors shall not be allowed go beyond the visitor's room.
- **4.4** Every resident of the hostel shall make an entry, while leaving and returning to the hostel, in the Entry-Exit Register. The resident shall take prior written permission from the warden if he/she has to stay out of the hostel after 9:30 P.M. for some unavoidable reasons.
 - 4.4.1 The resident shall make proper entry in the Entry-Exit Register.
- **4.5** The residents while going Home or Local Guardian's place or other place shall seek prior permission from the warden on the prescribed leave form of the University.
 - 4.5.1 In case warden is not satisfied with the reason, then approval of the Dean, Students

- Welfare shall be required. Such approval shall be obtained on the prescribed leave form of the University.
- 4.5.2 The student's copy of the permission slip must be shown to the guard before leaving for home or Local Guardian's place.
- 4.5.3 It is compulsory for every resident to submit the student's copy of the permission slip duly signed by parents/Local Guardian's on returning from home or Local Guardian's place.
- 4.5.4 If the resident's stay at home or at Local Guardian's place exceeds the time duration that is mentioned in the permission slip, the parents or guardian shall inform the warden in this regard through letter duly signed.
- **4.6** The resident shall not remain in the hostel during class hours except with prior permission of the Warden and, that too, on the justified grounds.
- 4.7 The change of address or phone/mobile number of the parents or Local Guardian shall be immediately communicated to the warden in writing by the parents. Residents shall submit their cell phone number in the hostel office and inform the warden in case of any change in the number.
- **4.8** Residents shall ensure that their rooms are locked properly before they leave.
 - 4.8.1 The resident shall deposit the duplicate keys of the room in the hostel office.
 - 4.8.2 The Residents desirous of keeping expensive items, shall do so at their own risk and the University shall not be responsible.
- 4.9 In case of any complaint regarding the fittings or repair in the room, the resident is required to leave his/her keys of the room with the guard in order to get the work done.
- **4.10** The Residents shall avoid littering, use dustbins and maintain hygiene.
- **4.11** The occupants of the room shall be responsible for the maintenance of the furniture and fixtures of his/her room. No furniture shall be removed in the hostel from one place to another without the prior permission of the Warden. He/She shall hand over the charge of the articles to the warden at the end of each Academic Session.
- **4.12** A resident may be provided the ambulance of the University for visiting the nearest PHC/CHC on medical grounds only. All the medical expenses except first aid shall be borne by the resident himself/herself.
- **4.13** The Residents shall not create any nuisance for other residents as well as to the general public. 4.13.1 The residents shall not indulge in mid night parties or gathering.
- **4.14** The resident of the hostel shall not possess/use any weapons, licensed or unlicensed.
- **4.15** The resident of the hostel shall not possess/use any prohibited drugs, liquor or cigarette/e-cigarettes and any other prohibited intoxicating substance.
- **4.16** The residents shall not keep any two/four-wheeler in the hostel campus.
- **4.17** The residents shall not use electrical appliances other than the one permitted by the University. Any resident found in violation of this regulation shall be subject to disciplinary action.
- **4.18** The Residents shall not cook food in the hostel premise/rooms.

5. Hostel Mess:

- 5.1 All residents shall accept the responsibility of the membership of the Mess Committee by rotation.
- 5.2 It shall be compulsory for every resident to take their meals in the hostel.
- 5.3 The Residents shall take their meal in the dining hall of the mess. Mess crockery/utensils shall not be taken outside of the mess. However, the meals may be served in the room provided it is permitted by the warden.
 - 5.3.1 Proper discipline, etiquette and manner of the Dining Table shall be maintained.
 - 5.3.2 Residents are not permitted to enter into the Pantry, Cooking area unless specifically authorized by the competent authority.

6. Hostel Campus

- 6.1 The residents shall stay in their respective rooms and shall avoid visiting the rooms of other fellow residents after the prescribed timing unless it is necessary for academic purposes and that too with the prior permission of Warden.
- 6.2 The Main Gate of the Hostel shall be closed at 9.30 p.m. and entry of the residents shall be permitted after recording reasons of delay. The residents found without valid permission shall be dealt with as per the rules.
- 6.3 The Residents are required to take care of the University property and articles issued to them by the University for bonafide use. Any damage/loss of the property shall be borne by the concerned resident in addition to disciplinary action as per the merit of the case.

7. Visitors

- 7.1 The Residents shall inform about the visiting hours to their parents, friends so that visit of the guest/s inside the Campus can be facilitated.
- 7.2 Entry of the female visitor/s into male hostel/s and vice versa without the permission of warden shall be prohibited. Close relative may visit the hostel only after informing the warden for short period during the day that to the visitors' Lobby rather than the resident's room.

8. Disciplinary Control:

- 8.1 Except as otherwise provided in any other Regulations of the University, any act, in violation of these Regulations, shall be act of indiscipline.
- 8.2 Every resident of the hostel shall be subject to the disciplinary control and jurisdiction of the authorities as provided in the Himachal Pradesh National Law University Discipline among Students/Residents Regulations 2019.

9. Power of Inquiry from Residents and Search & Seizure:

- 9.1 The Dean Students Welfare or Warden or any authorized person of the University shall have the power to demand from the residents their identity cards and such other information as may be required.
- 9.2 the Dean Students Welfare or Warden or any authorized person of the University shall have the authority of search and seizure of any material which is prohibited according to the Himachal Pradesh National Law University Discipline among Students/Residents Regulations 2019 with reference to the residents and their rooms.

Relevant rules related to discipline among students within and outside the University as contained in Himachal Pradesh National Law University, Shimla Disciple among Students/Residents Regulation, 2019 are reproduced below:

1. Short Title, Extent, Commencement, Scope and Application

- (1) These regulations may be called, the HPNLU Discipline among Students/Residents Regulations, 2019.
- (2) These Regulations shall be applicable to all the students/Residents of HPNLU on Roll in all the courses/Hostels.
- (3) These Regulations shall come into force w.e.f. 25th December, 2019.
- (4) All HPNLU students/residents are required to maintain good conduct, discipline and decency within and outside the University.
- (5) Any student/resident who commits breach of this regulation or act of any kind of indiscipline shall be liable to be punished under the HPNLU Regulations.

2. Indiscipline

Indiscipline is categorized according to the gravity of the act as under:

- 1) Indiscipline (2) Serious Indiscipline (3) Grave Indiscipline
- 3. The following acts are identified as acts of indiscipline in different categories:
- (1) **Indiscipline:** Incidents of Indiscipline shall include the following:
 - (i) causing disturbance in the classroom/hostels
 - (ii) Misbehavior with staff/employees of the University or contractors
 - (iii) abusing/insulting the fellow students
 - (iv) leaving campus/hostel without permission
 - (v) reporting late at class/Hostel
 - (vi) allowing any guest to stay in hostel room
 - vii) cooking meals in the hostel room
 - (viii) changing room without the permission of the Warden
 - (ix) using unauthorized electric gadgets in hostel rooms
 - (x) organizing parties in the hostel rooms
 - (xi) bringing vehicle at the University Campus without permission
 - xii) any other act notified by the University from time to time
- (2) **Serious Indiscipline:** Incidents of Serious Indiscipline shall include the following:
 - i) Misbehavior with Teacher/University authorities/warden.
 - (ii) use/bringing/supplying/possessing prohibited drugs, liquor or cigarette/e-cigarettes and any other prohibited intoxicating substance at the Campus/hostel
 - (iii) Third incident of indiscipline in one academic session or fifth incident of indiscipline in the course.
 - (iv) threatening/intimidating fellow students/employees
 - (v) vulgarity in any form
 - (vi) damaging or defacing University property
 - (vii) theft in hostel or at the Campus
 - (viii) any other act notified by the University from time to time

(3) Grave Indiscipline: Incidents of grave indiscipline shall include the following:

- (i) ragging in any form (ii) physical assault on any person in the campus/hostel
- (iii) indecent behavior of sexual nature in the campus/hostel (both consensual and non-consensual)
- (iv) any act of violence or moral turpitude that is an offence under any law in force in the

country committed in or outside the campus

three repeated incidents of serious indiscipline shall be considered as grave indiscipline

4. Punishments for Indiscipline

Any student found guilty of indiscipline shall be liable to a fine up to Rs 10000/- with or without community Service in the form of duty in the library/computer lab/ hostel/any office/working place of the University for a period up to one week.

5. Punishment for Serious Indiscipline

Any student found guilty of serious indiscipline shall be liable to a fine up to Rs. 25000/-and/or expulsion from the Hostel with or without community service at the Library/Computer Lab/ Hostel/any office or other working place of the University up to two weeks.

6. Punishment for Grave Indiscipline

A student found guilty of grave indiscipline shall be liable to a fine as determined by the Vice-Chancellor OR debarred from examination with or without fine OR rusticated from the University/Hostel.

Explanation:

- (i) Debarring of the student from an examination may be for one or more papers in a semester/semesters.
- (ii) Rustication shall be construed as expulsion of the student from the University for all times.

7. Procedure to deal with act of Indiscipline

- (1) On commission of an act of indiscipline, the matter shall be reported by the Warden/Teacher/ Officer/Security men/other concerned person to the Dean Students Welfare.
- (2) The Dean Students Welfare shall hold an inquiry into the matter himself or through a Committee of the following:
 - (1) Warden/Teacher concerned (2) Nominee of the Vice-Chancellor
- (3) The Dean Students Welfare/the above said fact finding Committee, as the case may be, shall give the opportunity of hearing to the concerned students and collect the relevant evidence. In case the enquiry is done by the Committee it shall on completion of the inquiry, submit the report to the Dean Students Welfare.
- (4) The Dean Students Welfare, if satisfied on enquiry by himself or with the findings of the Committee on guilt, shall give an opportunity of hearing to the student on proposed punishment and may impose the appropriate punishment as per these Regulations.

8. Procedure to deal with "Serious Indiscipline"

- On commission of an act of serious indiscipline the Administrative Officer/ Warden/ Teacher/ Officer of the University shall report the matter to the Dean Students Welfare.

 Provided that in case where student/resident is suspicious of using alcohol, he/she may be required to submit himself/herself for medical testing including testing through an alcometer.
- 8.2 On receipt of report the Dean Students Welfare shall conduct a preliminary inquiry and if satisfied that act of the student amounts to an act of serious indiscipline, shall submit a report to the Vice-Chancellor through Registrar.
- 8.3 The Vice-Chancellor may constitute a Committee that may comprise the following to inquire into any act of serious indiscipline:
 - 1. Registrar 2. Dean Students Welfare. 3. Administrative Officer, if any
 - 4. Two Wardens/Senior Teachers to be nominated by the Vice-Chancellor
- 8.4 The Committee shall give an opportunity to the concerned student to explain his/her position and shall also collect/record relevant evidence.
- 8.5 If the student is found guilty, the Committee shall give an opportunity of hearing to the guilty student on nature and quantum of proposed punishment.

After the hearing, the Committee shall make its recommendations to the Vice- Chancellor regarding guilt and also nature and quantum of the proposed punishment.

9. Procedure to deal with acts of "Grave Indiscipline"

- (1) On commission of an act of grave indiscipline the matter shall be immediately reported to the Vice-Chancellor by anyone having the information about the "grave indiscipline".
- (2) On the basis of the information/preliminary report, the Vice-Chancellor may pass an order of suspension of the student from classes or/and order vacation of hostel by the student involved in grave indiscipline.
- (3) The Vice-Chancellor may constitute a Committee which may comprise the following to inquire into the matter:
 - (i) Registrar (ii) Dean Students Welfare (iv) A Senior Teacher (v) Hostel Warden
 - Dean Students Welfare (iii) Administrative Officer Hostel Warden

HOSTEL RULES

- (4) The Committee shall hold inquiry and collect relevant information/ evidence about the incident. The concerned student shall be given opportunity to explain his/her position.
- (5) The Committee shall submit its report on the facts and circumstances of the case, as also its finding on the guilt of the student, after giving an opportunity of hearing to the student on the quantum of punishment, to the Vice-Chancellor along with proposed nature and quantum of punishment.
- (6) The Vice-Chancellor shall pass an appropriate order/punishment as per these Regulations.
- 10. Notwithstanding anything prescribed in these Regulations, act of ragging shall be inquired into, the award of punishment and the appeal shall be in accordance with the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 as amended from time to time.
- 11. In case of grave indiscipline attracting punishment of debarring the student from examination/rustication from the University, the result of the student shall be withheld and shall be subject to the decision of the Executive Council in such cases of indiscipline.

12. Appeal

12.1 In cases of different kinds of indiscipline under Rules 7, 8 & 9 appeals shall lie in accordance with the following scheme:

Provided that in cases of indiscipline and inquiry thereof under Rule 7, the appeal shall lie to the Registrar, whose decision/s shall be final.

In cases of indiscipline and inquiry thereof under Rules8 & 9 the appeal shall lie to the Vice-Chancellor, whose decision/s shall be final, except in cases where the punishment awarded is debarring the student/s from examination and rustication of the student/s from the University or hostel, the decision of the Vice-Chancellor along with the report of the Inquiry Committee and reply file by the student shall be submitted to the Executive Council for confirmation. Provided further that the Executive Council may take an appropriate decision on the guilt and

punishment after considering the recommendation of the Vice-Chancellor and, if required, perusal of the record of the case.

12.2 If punishment is awarded for committing an act of indiscipline as prescribed under Rule 4, the aggrieved party/student(s) may prefer an appeal before the Registrar within 15 days of communicating the punishment.

ATTENDANCE RULES

- 12.3 If punishment is awarded for committing an act of serious indiscipline as prescribed under Rule 5, the aggrieved party/student(s) may prefer an appeal before the Vice-Chancellor within 15 days of communicating the punishment.
- 12.4. If punishment is awarded for committing an act of grave indiscipline as prescribed under Rule 6, the aggrieved party/student(s) may prefer an appeal before the Vice-Chancellor within 15 days of communicating the punishment.
- **13. Powers of the Appellate Authority:** The Appellate Authority may, if it considers that there is no sufficient ground for interfering with the decision of the Inquiry Committee, dismiss the appeal, OR may reverse the finding of the Committee with or without altering the punishment OR with or without altering the finding, alter the punishment OR may reverse the findings and set-aside the decision of the inquiry Committee.
- **14.** Notwithstanding anything in these Regulations, a student may be suspended from the University and/or hostel pending an inquiry under these Regulations.

Relevant rules regulating attendance, conduct of students relating to Examinations and Promotion to subsequent year and award of degree as contained in Himachal Pradesh National Law University, Shimla (Examination) Regulation, 2019 are reproduced below:

3. ATTENDANCE

- 3.1 Attendance in Undergraduate Courses: No student of any of the Undergraduate Courses shall be allowed to sit for the end semester examinations in a subject if the student concerned has not attended minimum of 70% of the classes held in the subject concerned including the curricular moot court exercises, tutorials and practical training conducted in the subject taken together. Provided that if a student for any exceptional reasons fails to attend 70% of the classes held in any subject, the Vice-Chancellor may allow the student to sit for the end semester examinations if the student concerned has attended at least 65% of the classesheld in the subject concerned and attended 70% of classes in all the subjects taken together.
- 3.2 Attendance in Post Graduate Courses: A minimum of 75% attendance, in aggregate, shall be compulsory to appear in the end semester Examinations. A candidate who fails to obtain 75% of attendance shall not be allowed to sit in the examinations.
- 3.3 Academic leave: Academic leave shall only be granted by the Vice Chancellor on the recommendation of the Dean Academic Affairs. While applying for academic leave, the student shall specify the class hour(s) that he/she may be absent. The academic leave shall be given for a class hour/set of class hours, and not in terms of days. An academic leave form shall accordingly be filed and forwarded to concerned faculty for preparing attendance record.
- 3.4 The Academic leave to a student shall be considered, subject to the prior approval of the Vice Chancellor, or any person designated by him, for participation in moot court, arbitration, trial advocacy, client counselling and drafting competitions. It is further clarified that academic leave shall not be granted for participation in Summer School programmes, internships, job interviews, passport/visa interviews or examinations of any kind internal and external etc., under any circumstances.
- 3.5 Invitation for participation in any of the activities mentioned in 3.4, for which a student may be granted academic leave, should be addressed to and received by the University.
- 3.6 Academic leave shall not exceed 15% of the total classes in any given semester. The Academic leave shall include Travel/journey period.

- 3.7 In case a student is unable to appear, due to approved academic leave, in any examination, there shall not be any rescheduling of the said examination.
- 3.8 If a student is assigned any University assignment, duly granted by appropriate authority with the approval of the Vice chancellor, he/she shall be granted attendance for the period.
- 13. PROMOTION TO SUBSEQUENT YEAR AND AWARD OF DEGREE
- 13.1 Student securing at least 5.6 CGPA shall be awarded degree (Annexure-K).
- 13.2 Subject to Rule 13.6, a student securing 'C' grade in the requisite number of papers shall be promoted to subsequent year. If a student fails to secure 'C' grade or 5.6 CGPA in the requisite number of papers for the award of Degree she/he may apply for improvement under Rule 8. If the student has secured 'C' Grade in all papers, but fails to secure 5.6 CGPA, she/he shall have to improve the CGPA by reappearing in papers of his/her choice.
- 13.3 No student shall be promoted to the subsequent year of the Programme except by way of Rule 13.6 If a student who has been debarred from appearing in an end-semester examination due to shortage of attendance in a compulsory paper, she/he shall not be promoted to the subsequent year.
- 13.4 Subject to Rule 13.6, if a student is not being promoted to subsequent year of the course/program, he/she shall be required to re-register for the said course/courses when these are again offered, by paying the prescribed fees. Such students shall be evaluated for 100 marks (50+25+25), for the course(s).
- 13.5 A student who has been declared 'detained' due to shortage of attendance, and has not been promoted to the next year of the course/program, shall be required to take re-admission for the said course/programme in accordance with the HPNLU Courses of Study, Admission and Curriculum Regulations, 2019. Such student/s shall be evaluated as per the Himachal Pradesh National Law University, Examination Regulations, 2019.
 - Provided that when such student is declared 'detained' due to shortage of attendance in any even semester, he/she will be allowed to carry forward his course of odd semester.

Illustration:

- (a) A student of B.A./B.B.A. LL.B. 3rd Semester (Academic Session 2020-2021) is declared 'detained' due to shortage of attendance. He/she is required to take re-admission to 2nd year (3rd semester) in the Academic Session 2021-22.
- (b) A student of B.A./B.B.A. LL.B. 4th Semester (Academic Session 2020-21) is declared 'detained' due to shortage of attendance. He/she is required to take re-admission to 2nd year (4th semester again) in the Academic Session 2021-22.
- 13.6 Promotion Scheme to subsequent years shall be based on the following rules:

 For promotion to 2nd year A student shall have passed 70% of all papers i.e., 08 out of 12 papers of the 1st year.
 - For promotion to 3rd year A student shall have passed all papers of the 1st year and passed 70% of all papers i.e., 07 out of 10 courses of 2nd year For promotion to 4th year, a student shall have passed all courses of the 1st and 2nd years and passed 70% of all papers i.e., 07 out of 10 courses of the 3rd year
 - For promotion to 5th year, a student shall have passed all courses of the 1st, 2nd and 3rd years and passed 70% of all papers i.e., 07 out of 10 courses of the 4th year.
- 13.7 MAXIMUM NUMBER OF YEARS FOR COMPLETING UG/PG COURSE/PROGRAMME:
 A candidate who is enrolled in B.A./B.B.A. LL.B. Five Year Course (FYIC) shall have maximum 8 years to complete his/her degree.

 A candidate who is enrolled in LLM. One Year Programme shall have maximum 3 years to

A candidate who is enrolled in LL.M. One Year Programme shall have maximum 3 years to complete his/her degree.

Ragging is Crime



The immoral practice of 'Ragging' has become a menace; it is inhumane, thereby illegal and punishable. It not only violates the discipline and pollutes the benign aura of an educational institution but also adversely deteriorates the standards of higher education. An educational institution which is vowed to empower students by fostering healthy competitive, aspirational and inspirational atmosphere, this heinous practice of ragging causes fear and shock for the freshers and hurts the victim's psyche for life.

Ragging in educational institutions is banned by the Hon'ble Supreme Court of India. More so, the apex court has issued mandatory orders to curb the menace of ragging in educational institutions. Enshrined in the 3rd Amendment to UGC regulations on 29th June, 2016, Section 3(i) entails the definition of ragging as:

"Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of color, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background."

Owing to the seriousness and heinous character of this practice, HPNLU, Shimla has the policy of 'Zero Tolerance' to any kind of acts of ragging. In the eventuality where an applicant for admission is found to have indulged in ragging in past or if it is noticed later that he/she has indulged in ragging, his/her admission may be refused; his/her candidature may be cancelled or he/she may be expelled from the educational institution. The punishment may also be in other forms viz suspension from classes for a limited period, or fine with a public apology, debarring from representation in events, withholding results, suspension or expulsion from the hostel or mess, and the like. If the Head of the Institution is not satisfied with any of the aforesaid arrangements for action, a First Information Report (FIR) can be filed without exception by the institutional authorities with the local police. The discretionary power vests solely with the university authorities.

In accordance with the relevant UGC regulations, an Anti-Ragging mechanism is set up by the university, including awareness activities. The details of officers, contact numbers and procedure for redressal of complaints are displayed on the notice board and at appropriate places in the campus and hostel premises. HPNLU Shimla endeavours to keep intact its sanctity as the temple of knowledge and any student demeanour found to be counterproductive to this endeavour shall be taken to task.
