1. The students who intend to deposit the fee through Demand Draft on account of their education loan are advised to request their Banker to deposit the fee through **SBI Collect to Himachal Pradesh National Law University (H.P.)** or through Demand Draft in favour of **Registrar, Himachal Pradesh National Law University**.
2. Students who have already paid the 2<sup>nd</sup> Instalment of fees for the Academic Session 2023-24 may ignore this notice.
3. The above fee does not include the Mess Fee and will be informed separately regarding payment of Mess Fees.
4. Students are required to pay the fees through ERP. No fee will be accepted except ERP (SBI Epay).

5. The students are advised to deposit the fee much before the last date to avoid late fine as per University norms. The rule is reproduced below:
1. *A penalty shall be imposed on students who fail to deposit prescribed fee, within the prescribed time. A student who pays annual fee beyond the prescribed time, but within 10 days from the last date, prescribed, for depositing the fee, shall be liable to fine of Rs. 2000/-*
  2. *A student who pays prescribed fee beyond the 10 days delay from the last date of prescribed time, but within 15 days shall be liable to fine of Rs. 5000/-.*
  3. *A student who fails to pay prescribed fee beyond 15 days from the last date of prescribed time shall be issued a notice of cancellation of his/her admission to the course. The responses to the notice shall be reported to and decided by the Executive Council.*
6. No students shall be allowed to reside in the hostel and attend the classes without submission of fees.
