Vice-Chancellor (Officiating) informed the Esteemed Members that the application for the post of Vice-Chancellor has been invited vide advertisement No. Adv. No. HPNLU-A(7)-11(ADVT.)/2024-7019 dated 27.01.2024, the last date for receiving application/nomination for the post is 29<sup>th</sup> February, 2024.

The agenda item was thoroughly deliberated upon by the members and name of Prof. (Dr.) V.
