Policy for Grant of Scholarship on Merit cum Means Basis

Scholarship will be given on the basis of merit and eligibility conditions mentioned bellows:

1. Students must have qualified all the papers in the previous class, on the basis of merit of each security is being guaranteed.
2. For the first year Students merit of CLAT will be considered his eligibility conditions for granting scholarship.
3. There must be minimum 70% attendance in the previous class. (Not applicable to students of 1st year of B.A./B.B.A. LL.B.)
4. Previous 3 years Income Tax return of the parent should be attached along with the application form.
5. One scholarship will be given to differently abled student.
6. Two Scholarships will be given to LL.M(pursuing) student; one of which will be for girl student.
7. Family income of the applicant should less than 2.5 lakh p.a.
8. 10 scholarships, 2 from each semesters; 1 each from B.A./B.B.A. LL.B will be given on the basis of merit cum means
9. Out of the 10 scholarships for B.A./B.B.A. LL. B, 3 scholarship will be given to girl students.
10. The amount of scholarship will be 25% of the Tuition Fee payable to the University.

The Scholarship committee of the Himachal Pradesh National Law University, Shimla will invite applications for selecting students for granting scholarship on the '**Merit cum Means Basis**' on the following Terms and Conditions:

1. First of all merit and then need of the applicants will be determined to grant scholarship.
2. The determination of merit will be as under:
 - (A) **If the Candidate is in First Year, then on the basis of CLAT Score:**
 1. **All India Rank in CLAT**
 2. **Mark sheets of 12th with percentage.**
 - * Enclose the copy of the documents pertaining to both the points above.
 - (B) **If the candidate has already been admitted to HPNLU, then on the basis of previous year/s merit then he/she is required to provide:**
 1. **All the Mark sheets of all the previous semesters.**
 2. **Attendance % as per the record of the University of all these semesters.**
