

Further, Dr. Girjesh Shukla suggested to create a google form for collection of data.	It was unanimously decided by the committee members that the IQAC should create template given under NAAC/BCI/UGC in excel sheet for the collection of data.
3	Collection of information regarding publication from students of University for IQAC record. Prof. (Dr.) Anand Pawar suggested to create a performa for the collection of data related to students' publications. Further, the committee members suggested to create/add separate column/form in examination/admission form to collect the information.
