Note:

1. The students who intend to deposit the fees through Demand Draft on account of their education loan are advised to request their banker to deposit the fee through SBI Collect to Himachal Pradesh National Law University (H.P.) or through Demand Draft in favour of Registrar, Himachal Pradesh National Law University, Shimla.
2. Students who have already paid fees for the Academic Session 2022-23 are required to complete the Admission process by filling out Admission Forms etc.
3. As per the rules it is mandatory for all the students to complete the requirements of Admission by paying fees i.e. Admission in 2nd Year, 3rd Year, 4th Year, and 5th Year. **Only those students who fulfill the mandatory requirements shall be allowed to appear in the Mid-Term Examination.**
