Submitted that under section 21 of the Himachal Pradesh National Law University Act 2016, the constitution of the Academic Council has been provided. Since, there is no clause which provides that all Professor(s) of the University be nominated as members of the Academic Council. Therefore, the University intends to propose to bring all professors of the University as members of the Academic Council.	Members were apprised about the Constitution of Academic Council as given under section 21 of the Himachal Pradesh National Law University Act 2016., which does not have any clause whereby the Professor of the University may be nominated as member of the Academic Council. The Hon'ble Vice-Chancellor put forth before the members that the University intends to bring in the knowledge of the esteemed members so that it may propose to the appropriate authorities to bring necessary change in the Act, so that all professors of the University may be nominated as members of the Academic Council. However, it was further discussed by the members that rather than having all the Professors as members of the council, a selected number by rotation may be considered. However, Hon'ble Vice-Chancellor further informed that since, as of now, revised roster there are only six (06) positions of Professor are there, therefore, all may be considered for nomination. It was further observed that clause (f) of section 21 also required change to bring two Associate Professors and two Assistant Professor rotation wise as member of the Academic Council. Further, the proviso to clause (f) of Section 21 needs to be deleted. **Item No. 19.12**

**REPORTING ITEMS**

1. Implementation of Central Information Commission order No CIC/ SA/C/ 2015/900116 dated August 27, 2015 received from Association of Indian Universities (AIU) regarding providing certified copies of evaluated answer sheets only at cost of ₹ 2.00 per page under RTI Act. The Council resolved to show copies only up to 3 months after result declaration.

**2. Following matters related to the Examinations Branch:**

**(a) Students of the 1<sup>st</sup> Semester (B.A./B.B.A. LL.B. and LL.M.) those are admitted after 5<sup>th</sup> Sept., 2024 had been given option for the mid semester examination held in October 2024.**

In the Academic Session 2024-2025 the admission process continued, in accordance with UGC guidelines, till the month of October. There were several students who took admission towards the end of September and therefore could not attend classes. Neither was there any possibility of conducting remedial classes. Such students, on the recommendations of the Admission Committee, were given the option to opt out of the mid-term component of examinations. Accordingly, the end term examinations for such students were conducted having a weightage of 75 (through conversion formula) marks. The same is reported to the esteemed Council.

**(b) Rule regarding requirement of Review of the Answer Scripts securing more than 85 %.**

While implementing the Rule, it was found that external members/examiners would have to be called and there are a large number of such scripts falling under the Rule. Moreover, in the internal component of examinations, students are entitled to see their answer sheets. The process envisaged by the Rule requires huge time which delays the process of result declaration. Accordingly, the implementation of the Rule was put on hold with the approval of Hon'ble Vice-Chancellor and the same is reported here to the Esteemed Council.

**(c) Representation of Mr. Rajat Jhirwal (1020220150) Reappearing Student of B.A. LL.B. 3<sup>rd</sup> Semester regarding different questions for the Legal Method, Methodology and Legal Writing (LB-102) subject in the Mid term Re appearing Examination held in October 2023.**

The student applied for reappear examinations in the Course, Legal Method and methodology Academic Session- 2023-2024. Meanwhile, the course Content of the subject had undergone changes. out of the four modules of the syllabus, one was different. The question paper was framed as per the new syllabus. Accordingly, and in the interest of fairness, on the recommendations of the BOS grace of 5 marks were awarded to Mr. Rajat Jhirwal and Ms. Vasundhara Awasthi (1020220074) who had the identical case.

**(d) Difficulty in the Practical inapplicability of the Rule suggested in the Academic Council / Executive Council meeting held on 2<sup>nd</sup> June, 2023.**

The Examination branch was faced with the problem while implementing the proposal regarding securing 45% marks in each of the components of the examinations. While implementing the Rule, it was found that in many cases students who may secure more than even 60% in aggregate were to be given "G" (i.e., Grace Marks reflecting in their marksheets which was against the normal logic of examinations. Accordingly, implementation of the rules were deferred with the approval of the Vice-Chancellor and the same is being reported as part of Agenda for consideration.
