Guidelines to deposit the Fees: -

1. The Academic Fee (except for LL.D. and Ph.D. programmes) shall be payable in two instalments, i.e., Odd Semester and Even Semester, as per the fee structure notified by the University from time to time.
2. Students shall be required to pay the fee within the prescribed time for each semester (Odd and Even) as notified by the University from time to time.
3. After the last date to deposit the fee, late fee fine will be applicable as per the University norms elaborated below:
 1. Up to 10 days after due date: ₹2,000 fine
 2. 11-15 days after due date: ₹5,000 fine
 3. Beyond 15 days: Notice for cancellation of admission (subject to EC decision).
4. All fees and charges specified in this Manual shall be rounded off to the nearest multiple of ₹10/- wherever applicable.

5. Year Back due to Fail in Paper: -

- If a student is awarded a year back due to failing in paper(s) in any particular year, they are required to take re-admission in the next Academic Year for the said course/programme.
- The student shall be required to pay the **full fee** as per the fee structure of that year, including a **Re-registration Fee as mentioned above.**

6. Year Back due to Shortage of Attendance: -

- If a student is awarded a year back due to shortage of attendance in any semester, and is not promoted to the next year of the said course/programme, they shall be required to take re-registration for the said semester in the next Academic Year and required to pay the fees for that semester only.

7. Annual Increase in Fees: -

- There shall be an annual increase of **5% in the total Annual Fees** for each **new batch** admitted in every Academic Session except **Refundable Security.**
- There shall also be an annual increase of **5% (except Admission Fee & Refundable Security) in the fees for existing batches** of every programme in each Academic Session. This increase shall equally apply to supernumerary seats.

8. Mode of Fee Payment: -

- The University shall not accept fee payment through any mode other than **SBI Epay.**
- The fee payment form shall be made available on the University website: www.hpnlu.ac.in.

9. Mess Fees: -

- The prescribed fee structure does not include mess fees.
- The **Mess fees shall be payable separately** and shall **depend on the rates finalized through the tender process** conducted every year. Separate notification will be issued for the same.

10. NRI/International and SAARC Students (Excluding Indian Nationals):-

- The fees for NRI/International and SAARC students (excluding Indian nationals) shall be paid semester wise, and will be in addition to all other applicable fees.

11. Courier / Postal Charges for Dispatch of Academic Documents:

- For dispatch of academic documents (per document) such as transcripts, degree certificates, provisional certificates, and other certificates to students, a courier/postal charge of ₹500/- shall be levied for domestic dispatches and ₹7,000/- per courier/postal for international dispatches.
