## About the Competition

## Theme

## Eligibility

The competition is open to all the students pursuing UG/PG law courses in India.

## Registration Guidelines

- The registration shall be made through the google form given below.
- Registration fee is Rs. 500/- per person.
- Co-authorship is allowed up to a maximum of two authors.
- Multiple entries for individual authors are not allowed.
- A participant may submit an entry related to ONE sub-theme ONLY.

## Submission Guidelines

- All submissions are to be made through an e-mail at [cps@hpnlu.ac.in](mailto:cps@hpnlu.ac.in).
- A Cover Page should be attached including the Participant's Name, Batch, Phone Number, Email Address, Title of the essay Transaction ID.
- Submissions shall be in English
- Submissions should be original, unpublished and non-plagiarized nor should it be under consideration for publication or a contest elsewhere. The similarity index should be below 10%.
- The students who have made a solo entry and as a co-author also will be treated as multiple entries and it will lead to rejection of the second submission (The entry which is received first will be entertained)
- Any identification mark (in any form) in the essay shall lead to disqualification.

- Word limit: 3000-5000 words.
- For citation and references the Bluebook, A Uniform System of Citation (20th Edn.), should be strictly followed.
- Font: Times New Roman; Font size-12; Spacing- 1.5.
- Submit your entry as .doc or .docx.
- Submissions received after the last date shall not be considered
- The decision of the Selection Committee shall be final.
