This is to be noted that Ph.D. programme is governed the Himachal Pradesh National Law University (HPNLU), Shimla Regulations for Doctorate of Philosophy (Ph.D.) Programme, 2019 (<https://hpnlu.ac.in/PDF/8804ad18-0fe6-4563-86f6-130785411d15.pdf>.) Rule 4.3(e) of the Regulation further provides that nature of Ph.D. Programme may be full time as well as part time: -

“4.3 (e) The approved candidate may be allowed to be registered for the Ph.D. Programme as Full Time or Part Time Researcher.”

Rule 4.5 provides provisions for Course Work:

“4.5 A research scholar provisionally admitted to Ph. D. programme shall be required to undergo Ph.D. course work as prescribed under Rule 6. The research scholar

shall have to qualify the coursework as per the Himachal Pradesh National Law University Examination Regulations,” 2019. The duration of the course work shall be of one semester span. A scholar failing to qualify in the course work shall be given another chance to re-appear in the examination. If a scholar fails to qualify even in the second attempt, his/her admission shall be cancelled”
