CORREGENDUM: GENERAL INSTRUCTIONS FOR THE ADMISSION CLAT COUNSELLING: 2024

This Corrigendum is issued to the general instruction for the CLAT Counselling 2024 dated 20th Dec., 2024 as circulated by the Consortium of National Law Universities vide their corrigendum dated 06th May, 2024. The candidates who are participating in the counseling of 4th and 5th rounds and allotted Himachal Pradesh National Law University (HPNLU) through CLAT 2024 for Admission to B.A.LL.B. (Hons.)/ B.B.A. LL.B.(Hons.) (Five-Year Integrated Programme), and LL.M. (One Year Programme) for the Academic Session 2024-25 are required to take note of the following instructions and adhere with: -

1. Admission Counselling Process.

- 1.1 To exercise the FLOAT option in First or Second or Third or Fourth round of the Counselling, the candidates must pay the Confirmation Fee within the time stipulated in the Admission Counselling time frame as mentioned in the para 4 below.
- 1.2 The FLOAT option will expire after the fourth round of counselling, will not be available for the fifth and final round of counselling, and the last allotted seat will be considered final. At this point, candidates will have to choose to either "Freeze" or "Exit" the Admission Counselling Process.
- 1.3 The eligible candidate who has been allotted a seat as per their indicated NLU preference will be required to pay a non-refundable confirmation fee of ₹ 20,000/- (Rupees twenty thousand only) prior to selecting a "Freeze" or "Float" option in the First, Second, Third, Fourth and Fifth rounds of counselling. A candidate needs to pay the confirmation fee only once in the entire admission and counselling process.

2. Refund of the Counselling Registration Fee.

- 2.1 In full, if the Exit option is exercise before 1:00 PM on May 23, 2024.
- **2.2** After deduction of ₹ 5,000/- (Rupees five thousand only) if exercise after 1:00 PM on May 23, 2024

3. Fee payment at the HPNLU.

- 3.1 All candidates who have selected the Freeze option in the first, second, third, fourth or fifth round of the counselling must pay the balance of university fee (after adjusting for the counselling registration fee and Confirmation fee already paid to Consortium of NLU's) as prescribed within the stipulated time in the admission counselling Calander Para 4 below. Any such candidate who fails to pay their balance university fees by the given date will be deemed to have chosen the "Exit" option and will forfeit their seat and the Confirmation fee, and will receive a refund of the Counselling Registration Fee after deduction of ₹ 5,000/- (Rupees five thousand only) from CLAT.
- 3.2 Candidates who are allotted a seat in the Fourth round of counselling and who select the Float option in such round must pay the Confirmation fee within the stipulated time in the admission counselling calendar in para 4 below.
