




Vice-Chancellor Himachal Pradesh National Law University Shimla

# **ABOUT THE UNIVERSITY**

HPNLU, Shimla is recognised by the UGC under Section -2(f) of the UGC Act, 1956.The Bar Council of India has also recognised the University.



The Himachal Pradesh National Law University, Shimla, placed in the geographical terrains of the Himalayas is in the fifth year of its existence under the dynamic leadership of the Vice-Chancellor, Professor Nishtha Jaswal. The institution is one the few educational centres in the country which enjoy the natural environment and magical beauty of locational topography, excellent and enjoyable weather conditions throughout the year. The University in these respects is bestowed with all natural conditions facilitative of creation, pursuit and dissemination of knowledge.

HPNLU, Shimla was established by the Himachal Pradesh National Law University Act, 2016 (Act 16 of 2016) in September 2016. The University shifted from the Himachal Pradesh Judicial Academy premises to its own campus during the academic session 2019-20. Equipped with state-of-the-art facilities, the new campus is already more than well under construction. The Academic and the Administrative Blocks are ready and the construction work of women's and men's hostel is on at a very rapid pace. The new campus has been developed by the Public Works Department (PWD), Government of Himachal Pradesh. The first phase of construction that included the Academic and the Administrative blocks and hostels for girls and boys is almost complete. The hostels are at a stage of completion and should be ready by early next year. The process for construction of residential complexes for teaching and non-teaching staff is yet to be initiated.





The University started functioning from 5th of October, 2016. It is a participating University of the Consortium of National Law Universities (NLUs). The Vice-Chancellor, Professor Nishtha Jaswal is a member of the Core Committee of CLAT 2020. The batches of B.A. LL.B. and B.B.A LL,B (Five year integrated course), LL.M. (One Year Programme) are admitted through CLAT (Common Law Admission Test). The University conducts every year, its own national level test for selecting candidates for the Ph.D. programme in law. Currently the fifth batch of Undergraduate students and the fourth batch of Post Graduate students and Ph.D. students are pursuing their respective courses.

Presently, students are provided hostel accommodation facilities in rented, private buildings that fall within a one-kilometre radius of the University. Conveyance facilities between hostels and campus are provided through the University bus. There is a central mess facility in each of the hostels. Hostel rooms are duly furnished with beds, study tables, chairs, mattresses and almirahs. Hygiene and proper sanitation are maintained and WiFi facilities are available. For safety and security of residents, each hostel has security guards.

The University has an ambulance facility and medical care is provided through the Government Hospital located at Dhami which falls within three kilometres from the University campus.



## LIBRARY

HPNLU Library functions as the primary information resource centre and acts as a centre of repositories of printed and electronic resources for the teaching and research needs of the University. The library has a rich collection of books and journals belonging to fields of law, economics, political science, management, sociology, psychology etc. The library currently houses more than 6000 documents.

The periodical section includes the Supreme Court Cases, All India Reporter, Criminal Law Journal, Harvard Law Review and Judgement Today, Columbia Law Review, Contributions to Indian Sociology, International Journal of Constituional Law, Oxford Journal of Legal Studies, the American Journal of Comparative Law, The British Yearbook of International Law, Journal of Intellectual Propety Rights, Himachal Law Reporter and the Cambridge Law Journal, to name a few.

The Reference Section includes the Law Reports, bare acts, commentaries, proceedings, Legislative and Constitutional material, Encyclopedias and dictionaries.

The Library facilitates access to following online databases- Westlaw, Hein Online, Manupatra, SCC Online, Lexis Nexis, Economic and Political Weekly (EPW) and Jstor.

The Library operations are automated using KOHA library management software. The online public access catalogue (OPAC) which is on public domain enables users to search documents in possession of the Library. It helps the users to search documents from the library holding and guides them to its location on stacks.

# **HOSTEL RULES**

THESE HPNLU REGULATIONS FRAMED UNDER SECTION 35 OF THE HIMACHAL PRADESH NATIONAL LAW

These regulations may be called, the Himachal Pradesh National Law University Hostel Regulations,

For effective implementation of these regulations various committees may be created by the Vice-

Dean Students Welfare: There shall be a Dean Students Welfare who shall be appointed by the Vice

2.1.1 The Dean Students Welfare shall be responsible for the hostel administration and all issues pertaining

2.1.2 The Dean Students Welfare shall also be responsible for the discipline issues in the University Campus. 2.1.3 The office of the Dean Students Welfare shall have staff including superintendent, clerk, steno typist, caretakers and a peon and shall be under general regulation of the University.

Warden: There shall be a warden appointed by the Vice-Chancellor for each hostel of the University. The Vice Chancellor may give additional charge of warden to any faculty member. However, the Dean Students Welfare, with the approval of the Vice Chancellor, may give charge of more than one hostel to

2.2.1 The Warden shall perform his/her duties in consultation with the Dean Students Welfare.

2.2.2 The office of the warden shall have staff, including clerks, attendants, security guards etc., and shall be

2.3 The Dean Students Welfare and Wardens shall be paid such honorarium as decided by the Vice-



#### Admission: HPNLU SHIMLA 3.

Students who have joined a regular course of B.A/B.B.A LL. B., LL. M. and Ph. D. in the University shall 3.1 be eligible for hostel accommodation for the duration of his/her course. The University shall have discretion to allot the Hostel accommodation to a particular student or a group of students based on the parameters of suitability and need, in the broader interest of the academic environment of the campus. The admission to the hostel shall be made on the filling of the prescribed form along with the following documents:

a. photocopy of the fee receipt, b medical disclosures/records specifically mentioning blood group, any serious disease and any specific allergies.

Any resident who is going to represent the University in any external event shall submit a copy of Academic Leave granted for the same to the office of the warden.
- Entry time for the residents is 9.30 p.m. Parents/Local Guardians can meet them during visiting hours 4.3 prescribed by the University at the visitor Room

- 4.4 Every resident of the hostel shall make an entry, while leaving and returning to the hostel, in the prescribed form. The resident shall take prior permission from the warden if he/she has to stay out of the hostel after 9.30 p.m. for some unavoidable reasons.
- 4.4.1 The resident shall make proper entry in the Entry-Exit Register.
- The residents while going Home or Local Guardian's place or other place shall seek prior permission 4.5 from the warden on the prescribed leave form of the University.
- In case warden is not satisfied with the reason, then approval of the Dean, Students Welfare shall be 4.5.1 required. Such approval shall be obtained on the prescribed leave form of the University.
- 4.5.2 The student's copy of the permission slip must be shown to the guard before leaving for home or Local Guardian's place.
- 4.5.3 It is compulsory for every resident to submit the student's copy of the permission slip duly signed by parents/Local Guardian's on returning from home or Local Guardian's place.
- If the resident's stay at home or at Local Guardian's place exceeds the time duration that is mentioned 4.5.4 in the permission slip, the parents or guardian shall inform the warden in this regard through letter duly signed.
- The resident shall not remain in the hostel during class hours except with prior permission of the 4.6 Warden and, that too, on the justified grounds.
- The change of address or phone/mobile no of the parents or Local Guardian shall be immediately 4.7 communicated to the warden in writing by the parents. Residents shall submit their cell phone number in the hostel office and inform the warden in case of any change in the number.

- 4.8.2 The Residents desirous of keeping expensive items, shall do so at their own risk and the University shall not be responsible.
- In case of any complaint regarding the fittings or repairing in the room, the resident is required to leave 4.9 his/her keys of the room with the guard in order to get the work done.
- The Residents shall avoid littering, use dustbins and maintain hygiene. 4.10
- 4.11 The occupants of the room shall be responsible for the maintenance of the furniture and fixtures of his/her room. No furniture shall be removed in the hostel from one place to another without the prior permission of the Warden. He/She shall hand over the charge of the articles to the warden at the end of each Academic Session.
- 4.12 A resident may be provided the vehicle of the University only on medical grounds. All the medical expenses except first aid shall be borne by the resident himself/herself.
- 4.13 The Residents shall not create any nuisance for other residents as well as to the general public.
- 4.13.1 The residents shall not indulge in mid night parties or gathering.
- 4.14 The resident of the hostel shall not possess/use any weapons, licensed or unlicensed.
- 4.15 The resident of the hostel shall not possess/use any prohibited drugs, liquor or cigarette/e-cigarettes and any other prohibited intoxicating substance.
- The residents shall not keep any two/four-wheeler in the hostel campus. 4.16
- The residents shall not use electrical appliances other than the one permitted by the University. Any 4.17 resident found in violation of this regulation shall be subject to disciplinary action.
- The Residents shall not cook food in the hostel premise/rooms. 4.18

#### 5. Hostel Mess :

- 5.1 All residents shall accept the responsibility of the membership of the Mess Committee by rotation.
- 5.2 It shall be compulsory for every resident to take their meals in the hostel.
- 5.3 The Residents shall take their meal in the dining hall of the mess. Mess crockery/utencils shall not be taken outside of the mess. However, the meals may be served in the room provided it is permitted by the warden.
- 5.3.1 Proper discipline, etiquette and manner of the Dining Table shall be maintained.
- 5.3.2 Residents are not permitted to enter into the Pantry, Cooking area unless specifically authorized by the competent authority. HPNLU SHIMLA

#### 6. Hostel Campus 📃

- The residents shall stay in their respective rooms and shall avoid visiting the rooms of other fellow 6.1 residents after the prescribed timing unless it is necessary for academic purposes and that too with the prior permission of Warden.

- The Residents are required to take care of the University property and articles issued to them by the 6.3 University for bonafide use. Any damage/loss of the property shall be borne by the concerned resident in addition to the disciplinary action as per the merit of the case.

#### 7. Visitors

- 7.1 The Residents shall inform about the visiting hours to their parents, friends so that visit of the guest/s inside the Campus can be facilitated.
- Entry of the female visitor/s into male hostel/s and vice versa without the permission of warden shall be 7.2 prohibited. Close relative may visit the hostel only after informing the warden for short period during the day that to the visitors' Lobby rather than the resident's room.

#### 8. Disciplinary control :

Every resident of the hostel shall be subject to the disciplinary control and jurisdiction of the authorities as provided in the Himachal Pradesh National Law University Discipline among Students/Residents Regulations 2019.

Punishments for Indiscipline Any student found guilty of indiscipline shall be liable for fine up to '5000 with or without community Service in the form of duty in the library/computer lab/ hostel/any office/working place of the University for a period up to one week. 5. Punishment for Serious Indiscipline Any student found guilty of serious indiscipline shall be liable for fine up to '10000 with or without community service at the Library/Computer Lab/Hostel/any office or other working place of the University up to two weeks. 6. Punishment for Grave Indiscipline A student found guilty of grave indiscipline shall be-liable to a fine as determined by the Vice-Chancellor Or debarred from examination with or without fine Or HPNLU SHIMLA rusticated from the University/Hostel. Or, wherever, prescribed by the UGC from time to time.

Explanation: (i) Debarring of a student from examination may be for one or more papers in a semester/semesters or more than one semester. (ii) Rustication shall be construed as expulsion of the student from the University for all times. 7. Procedure to deal with act of Indiscipline (1) On commission of an act of indiscipline the matter shall be reported by the Warden/Teacher/ Officer/Security men/other concerned person to the Dean Students Welfare. (2) The Dean Students Welfare shall hold an inquiry into the matter himself or through a Committee of the following: (1) Warden/Teacher concerned (2) Nominee of the Vice-Chancellor (3) The Dean Students Welfare/the above said fact finding Committee, as the case may be, shall give the opportunity of hearing to the concerned students and collect the relevant evidence. In case the enquiry is done by the Committee it shall on completion of the inquiry, submit the report to the Dean Students Welfare. (4) The Dean Students Welfare, if satisfied on enquiry by himself or with the findings of the Committee on guilt the Committee give an opportunity of hearing to the student on proposed punishment and may impose the appropriate punishment as per these Regulations.

(5) For any grievance regarding disciplinary action under these provisions a student may make an application for review to the Registrar. The decision of the Registrar shall be final, for all matters of indiscipline.

8. Procedure to deal with "Serious Indiscipline" 8. On commission of an act of serious indiscipline the

Administrative Officer/Warden/Teacher/Officer of the University shall report the matter to the Dean Students Welfare. (2) The Dean Students Welfare shall conduct a preliminary inquiry and if satisfied that act of the student amounts to an act of serious indiscipline submit a report to the Vice-Chancellor through Registrar. (3) The Vice-Chancellor may constitute a Committee that may comprise the following to inquire into any act of serious indiscipline: HPNLU SHIMLA

1. Dean Students Welfare 2. Administrative Officer, if any 3. Warden/Senior Teacher to be nominated by the Vice-Chancellor (4) (i) The fact-finding Committee shall give an opportunity to the concerned student to explain his/her position and shall also collect/record relevant evidence. 9. If the student is found guilty the Committee shall give an opportunity of hearing to the guilty student on nature and quantum of proposed punishment. (iii) After the hearing, the Committee shall make its recommendations to the Vice-Chancellor regarding guilt and also nature and quantum of the proposed punishment.

10. The Vice-Chancellor on perusal of the recommendations of the above said Committee and record may pass an appropriate order/award punishment as prescribed by these regulations for indiscipline/ serious indiscipline. The decision of the Vice Chancellor shall be final.

9. Procedure to deal with acts of "Grave Indiscipline" (1) On commission of an act of grave indiscipline the matter shall be immediately reported to the Vice-Chancellor by anyone having the information about the "grave indiscipline". (2) On the basis of the information/preliminary report, the Vice-Chancellor may pass an order of suspension of the student from classes or/and order vacation of hostel by the student involved in grave indiscipline. (3) The Vice-Chancellor may constitute a Committee which may comprising the following to inquire into the matter: (i) Registrar (ii) Dean Students Welfare (iii) Administrative Officer (iv) A Senior Teacher (v) Hostel Warden (4) The Committee shall hold inquiry and collect relevant information/evidence about the incident. The concerned student shall be given opportunity to explain his/her position. (5) The Committee shall submit its report on the facts and circumstances of the case, as also its finding on the guilt of the student, to the Vice-Chancellor along with proposed nature and quantum of punishment. (6) (i) The Vice-Chancellor may pass an appropriate order/punishment as per these regulations and in case the punishment to be awarded is debarring the student from the Examination or rustication from the University or the Hostel, give an opportunity of hearing to the student/his or her parents. If Vice-Chancellor is of the view that punishment should be of debarring the student from examination or rustication of the student from the University or Hostel, report shall be submitted to the Executive Council along with substance of reply of the student. (ii) The Executive Council may take an appropriate decision on the guilt and HPNLU SHIMLA punishment after considering the recommendation of the Vice-Chancellor and, if required, perusal of the record of the case. 11. In case of grave indiscipline attracting punishment of debarring the student from examination/rustication from the University, the result of the student shall be withheld and shall be subject to the decision of the Executive Council in such cases of indiscipline.

#### PART-III

SAVING 1. Removal of difficulty: The Vice Chancellor is authorized to make necessary changes in these Regulations to remove difficulty and bring it in consonance with the corresponding statutory requirement.

## (Maintenance of Hostel Discipline)

Without prejudice to the generality of the foregoing provisions "indiscipline" and "misconduct" in the hostel shall include the following and if the allegation of indiscipline/misconduct against a resident is found correct, he/she will be liable to disciplinary action as indicated below:

1. Act of ragging in the Hostel	Rustication from the University and an FIR with the police authority.		
2. Leaving the hostel over-night without obtaining prior permission in writing from the Warden.	Warning and on repetition of this twice, the resident shall be expelled.

4. Accommodation of unauthorized guest in the hostel room.	-Do-		
5. Organizing games, sports other programmes etc. without informing the Warden	Imposition of fine and on repetition of this twice, the boarder shall be expelled.		
6. Playing of loud music or musical instruments causing nuisance.	-Do-		
7. Change of room in the Hostel without prior permission of the Warden.	-Do-		
8. Damage in any form to the hostel property.	Recovery of the actual loss besides the punishment as decided by competent authorities.		
B. Misbehavior in the Hostel:	Punishment		
1. Manhandling or physical assault of any Hosteller or mess staff.	Suspension from hostel, pending inquiry. The punishme at the discretion of disciplinary committee		
2. Manhandling, assault or battery of any one in the Hostel premises.	-Do-		
3. Removing any furniture or fixture of the Hostel without permission.	Rs. 200/- fine on each occasion. Repetition of this twice shall result in expulsion from the hostel.		
4. Use of any hallucinogenic drugs or alcoholic drinks or indulgence in intoxicants.	Expulsion from the Hostel.		
5. Keeping arms and other contraband material etc.	-Do-		
6. Illegal/ Unauthorized entry in the hostel.	Rustication from the rolls of the University. Apart from any other punishment as decided by the Vice-Chancellor on the recommendation of the Warden/ Proctorial Board.

Ragging as defined by 3rd Amendment in UGC Regulations on 29th June, 2016 to including the following:

1. 3 (i) "Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background".

HPNLU, Shimla has the policy of Zero tolerance to any kind of acts of ragging. Ragging being an evil practice, is inhuman, illegal and punishable. It violates the discipline of an educational institution and adversely affects the standards of higher education. Ragging in educational institution is banned by the Honorable Supreme Court of India. The Court has issued mandatory orders to curb the menace of ragging in educational institutions. If an applicant for admission is found to have indulged in ragging in the past or it is noticed later that he/she has indulged in ragging, his/her admission may be refused or he/she shall be expelled from the educational institution. The punishment may also be in other forms such as suspension from the classes for a limited period, or fine with a public apology, debarring from representation in events, withholding results, suspension or expulsion from hostel or mess, and the like. If the Head of the Institution is not satisfied with these arrangements for action, a First Information Report (FIR) can be filed without exception by the institutional authorities with the local police. The discretionary power vests solely with the University Authorities.

As per the relevant UGC regulations Anti-Ragging mechanism is setup by the University, including awareness activities. The details of officers, contact numbers and procedure for redressal of complaints are displayed on the notice board and at appropriate places in the Campus and Hostel Premises.


