Q.2 In a case of *Suraj v Vinod*, SCR 1914 (2024), Suraj, the appellant, was convicted under the charges of theft after a trial where the only evidence presented was circumstantial. The prosecution argued that Suraj was the only person who could have committed the theft, given the location of the crime and his proximity to the scene. As a result of this Suraj filed an appeal, claiming that a conviction based solely on circumstantial evidence violated his right to a fair trial under the Constitution. The case leads to formulation of two main issues, i.e. whether circumstantial evidence alone is sufficient to

secure a conviction for theft and whether the trial court erred in not giving enough weight to Smith's alibi defense.

The court delivered the judgment where Justice Chanderkant emphasized that the conviction of Suraj was based on a careful evaluation of the circumstantial evidence presented by the prosecution. The court affirmed the principle that circumstantial evidence, if compelling and leading to a reasonable inference of guilt, and therefore it can be sufficient to sustain a conviction. It was stated by the judge, "It is well established in law that where the circumstantial evidence, when taken together, establishes a clear and unequivocal connection between the accused and the crime, it can be sufficient for a conviction. The fact that direct evidence is absent does not, in itself, make the circumstantial evidence inadmissible. The conviction in this case, based on circumstantial evidence, is therefore legally valid." While addressing the Suraj's claim about the alibi defense, Justice Chanderkant remarked: "While Suraj's alibi was not adequately substantiated, we recognize that the application of the 'beyond a reasonable doubt' standard should always take into account the possibility that the accused may have been elsewhere. However, in prosecution's circumstantial evidence was this case, the sufficiently compelling to rebut Suraj's alibi. We note, however, that in future cases, courts may wish to be cautious when considering alibis, and take into account the potential for more sophisticated methods of verifying alibi claims, such as digital evidence." Finally, it was concluded that, it is high time for the legislature to consider whether the current rules surrounding circumstantial evidence and alibi defense need to be reformed. While the law in this area is settled, the use of modern technologies in evidence gathering could significantly change how we approach these issues in the future. Thus, the court unanimously upheld the conviction, affirming that circumstantial evidence can form the basis of a conviction if it is strong and

conclusive. The appeal was dismissed.

The judgment discussed above consists of the *obiter dicta* and *ratio decidendi*, while explaining the significance and role of both expressions, discuss precedent as a source of law. Further, identify the *ratio decidendi* and separate it from the *obiter dicta* in the given judgment. Support your answer with the help of readings and case illustrations.

Q.3 Over the past decade, many countries and states within countries have taken steps to decriminalize or legalize cannabis for recreational use. While these legislative changes are often hailed as progressive and beneficial for public health and criminal justice reform, they also raise numerous legal and social challenges. These include concerns about the impact of cannabis legalization on public health, crime rates, economic factors, and societal norms.

In country X, a recent referendum passed a law legalizing the recreational use of cannabis for adults aged 21 and over. The law allows individuals to purchase cannabis from licensed dispensaries, consume it in private spaces, and cultivate a limited number of plants for personal use. However, the law is not without controversy. Critics argue that legalization may lead to an increase in substance abuse, driving under the influence (DUI) incidents, and youth access to cannabis. Supporters, on the other hand, contend that legalization will reduce the burden on the criminal justice system, eliminate the black market, and generate tax revenue for the government. There has been growing concern about how this new legal landscape will impact communities, particularly vulnerable populations such as adolescents, low-income individuals, and people of color, who have been disproportionately affected by past drug laws. Additionally, while many have expressed optimism about the economic benefits of cannabis legalization, questions remain about the regulation of the industry, advertising practices, and the potential risks of normalizing cannabis use in society. As the new law takes effect, social scientists, policymakers, and legal scholars are keen to understand how the legalization of recreational cannabis affects both the legal system and broader social norms. This is the reason the law department of the country has invited research proposals form young law students on this matter. While analyzing the aforementioned proposition frame a research proposal with specific mentioning of statement of problem; research objectives; research methodology for the work.

Q.4 A government has enacted a new law that criminalizes certain forms of protest, arguing that maintaining public order is essential for the stability of society. The agency refuses to process their application on the grounds of their sexual orientation, and when David and Miller try to file a lawsuit, they encounter further delays and prejudice from legal professionals who question the suitability of same-sex couples as parents.

Situation

Abrahi, a non-binary person, was subjected to a hate crime on the street, where they were physically assaulted and verbally harassed. When Abrahi reported the incident to the police, the officers dismissed the case, claiming that the situation was too "complicated" to investigate properly and that the victim's gender identity was irrelevant. The police offered no support, and Abrahi was left feeling that their safety and dignity had been violated without recourse.

During the experiment, participants are led to believe they've been falsely accused of a minor crime, with varying levels of evidence presented against them. The study aims to measure how these different interrogation methods impact the likelihood of participants "confessing" to a crime they did not commit. It was found that high-pressure interrogation techniques are more likely to lead to false confessions than supportive interview styles.

- Q.5 The Brown v. Board of Education case, decided in 1954 by the United States Supreme Court, is a landmark decision that declared racial segregation in public schools unconstitutional. Before this case, the "separate but equal" rule from Plessy v. Ferguson (1896) allowed schools to separate Black and white students, as long as the facilities were supposedly equal. However, schools for Black students were often far worse in quality. The families argued that separate schools harmed Black children, making them feel inferior and limiting their opportunities. The Supreme Court agreed, stating that "separate educational facilities are inherently unequal." This meant that schools could no longer segregate students by race. The ruling was a key moment in the Civil Rights Movement, helping to end segregation in schools and inspiring further actions for racial equality across the U.S. On the basis of this, answer the following questions:
 - (i) Analyze how would Charles Spearman explain this racial segregation with the help of his Two-factor theory of Intelligence.
 - (ii) Discuss how would this affect their Interpersonal and Intrapersonal Intelligence.
