Q.1 Short Answer Type Questions:


- A. A group of hoteliers joined hands and offered reduced rates of hotel stay and lucky draw in order to induce customer to stay only through them. In consequence of this, a hotel Swan Inn was kept out of the combination suffered loss. Hotel Swan Inn sues for damages alleging that defendants maliciously formed the group to kick him out of the trade. Decide as per the relevant cases and legal principles applicable in this case.
- **B.** The plaintiff was employed by a railway company to drill holes in a rock, near a crane, operated by men employed by the railway company. The crane lifted stones and at times swung them over the plaintiff's head without warning. The plaintiff was fully aware of the danger he was exposed to by working near the crane. One time, a stone fell off the crane and injured the plaintiff. He sued his employer for negligence.

Decide the case as per the relevant cases and legal principles applicable in this case.

C. Write a short note on Act of God.

- Q.2 Mr. Ram took a car from Sham & Com. on rent. In the rent agreement there was a clause that the company should not be liable for any personal injury to the hirer or any other person using the car. However, while driving the car Mr. Ram's brother was injured due to defect in the brakes of the car. Mr. Ram sued the Sham & Com. for damages. Decide the case.
- Q.3 Mr. X was carrying on a business in food grains. Its premises were visited by the Police Inspector, Vigilance Cell and huge stocks of food grains were seized. In the proceeding taken under Section 6-A of the Essential Commodities Act, 1955, no serious violation of any Control Order was found and only nominal portion of stock was seized and the rest was ordered to be released. When Mr. X went to take delivery of the stock, he found that the it was spoiled both in quality and quantity. Mr. X sued the State while establishing negligence on the part of its officers. Will Mr. X succeed in his suit? Decide the case.

Q.4 Mrs. S died because of the collapse of the Clock Tower, which belonged to Municipal Corp. of Shimla. Legal heirs of Mrs. S filed 3 different suits for damages in Court alleging MC of being negligent on the account that the clock tower was never examined seriously to check for defects, which made it unsafe to use. Whereas the MC contended that it was very heavy rainfall so nothing can be done by the MC. Decide as per the relevant legal provisions and case laws applicable in this case.
