#### Introduction:

Victimology is a relatively young branch of academic research. Its objective is to gain knowledge about victims of crime and abuse of power. Victimology has from its inception adopted an interdisciplinary approach to its subject matter. The main idea is to present an overview of the history and theory of victimology, analysis of victimization patterns with special emphasis on types of victims and crimes, the interaction between victims of crime and the criminal justice system with respect to the role of the victim and the services offered to the victim.
