## Module-1 Conceptualising Poverty

- 1.1 The concept of poverty units: Economical, Cultural, Situational; Distinction between "natural" and "social" poverty Absolute and relative poverty Poverty and its relation with Social and religious constructs.
  - 1.2 Conceptualisation of Impoverishment: Poverty line (Alagh Committee, Lakdawala Committee, Tendulkar Committee, Rangarajan Committee,)- Nutritional norm (Debate between Dandeker and Sukhatme); Income" and "consumption" criteria; The PQIL (the Quality of Life) indices; Heterogeneity of the poor and poverty line conceptions; Problems of data and India-wide generalization; The debate on "Crossing of the Poverty Line"; Constitutionality of criteria of poverty line as a basis of state action.
- 1.3 The "Determinants" of Impoverishment: Population growth as determinant; Legal system as a determinant.
  - 1.4 Planning as a determinant of poverty: The Nehru Phase (1950-1964), Green Revolution and basic needs strategies (1964-1977), the anti-poverty Programme strategy (1977-1988); Poverty of Planning and Anti-poverty Programmes SFDA MFAL, DPAP, IRDP, NREP, RLEGP "Food For Work", Identification of beneficiaries, Arbitrariness and application of "Poverty line" measures, Administrative structure weaknesses; Bank financing of IRDP Bank loans for poor and landless. MGNREGA, and DBT Jan Dhan Yojana, Aadhaar, Mobile, (JAM) trinity.
- 1.5 Constitutional Aspects of the Anti-poverty Programmes: Non-legislative character, Right to access to information, Problem of legal accountability, Judicial remedies for maladministration, Constitutionality of measures such as identification of beneficiaries and bank financing, Federal autonomy questions in centrally sponsored anti-poverty programmes.

- 2.1 The Bonded Labour Abolition Conceptualization, Administrative processes under the Act of 1976, Awareness of the act and legal services, *Bandhua Mukti Morcha*: Problems of judicial effectiveness
