3. The rates should be quoted as shown against the item for the material and stitching charges and should be inclusive of GST/taxes or other charges extra as applicable. The bidder should quote their rate including taxes if any, transportation, handling charges, labour charges etc .
4. The bids qualifying the technical stage i.e. approval of samples will be considered for opening of financial bid.
5. Each Firm must have **GST Registrations, PAN Card**. A copy of the same must be submitted along with the Quotation.
